Also, Chapter 3 has numerous examples of bridging discussions about patterns to reading analysis - some have students analyze text and others have students apply their understanding of the pattern to writing about their reading.

Additionally, within many lessons, students connect the pattern to their reading by finding examples of the pattern in a self selected or assigned text. The Invitations that require students to discuss patterns and their impact/effect on the reader facilitate many aspects of this standard. Applications include using the pattern in analytical writing as well as diving deeper into understanding the nuances of a text by using the pattern to analyze texts. The applications lend themselves to students using academic vocabulary in their conversations and in their writing.

Craft and Structure

All of the lessons offer model sentences, as well as models for further study, that allow for discussion around how usage is complex and tied to meaning, not rules. Collectively, they also model varied syntax and a variety of patterns. All lessons encourage and provide tools to foster this level of discussion and facilitate the understanding stated in the standards.

Each of the lessons offer varied usages of the convention through different:

- genres
- mediums
- purposes
- tone
- syntax
- literary devices
- rhetorical devices

Additionally, as Model Sentences are taken from published texts, many play with usage or "break rules" and use figurative language to impact their audience. This conversation begins with the first Invitation - Noticing - and is further explored in Compare/Contrast. As an example, 4.3 Colons that Introduce Lists uses asyndeton vs. a list that includes a comma/and.

Models for Further Study also ensures that the pattern can be explored in a variety of contexts as well as fiction and nonfiction.

Knowledge of Language 11-12L

Numerous lessons provide practice with varied syntax as well as consistent exposure to varied syntax through the Invitations to Notice and Compare/Contrast.

An example of this is Lesson 5.2 where students play with inserting the same phrase into an imitation sentence in different places and make decisions about the effectiveness of each choice. Students also discuss varied syntactical choices in each Invitation to Edit.
