(iii) Detectives:

The sub-section Commanders eg. Finance, Logistics and Human Resources reported to me. The Station was also an accountable station handling the finances of several stations in the cluster.

(v) Daily Station Crime Combatting (SCCF) meetings were chaired by myself and Crime and General issues discussed in full.

Pattern Analysis (CPA) and Threat Analysis (CTA) analysed and operations planned and executed.

(vi) Communication:

One of my most important functions were to liaise with the community, the Press and to assist Neighbourhood Watches. It was also my task to ensure that the Community Police Forum (CPF) operated in a sound and effective way.
