SUMMARY OF EVENTS

On 2008-05-12 the above mentioned members went on foot patrol in Site C , Bravo Block, Khayelitsha. A suspect was searched and found in possession of 61 (Boss) mandrax tablets. The suspect was interviewed properly by the members. The suspect then pointed out the storage facility in Ikhwezi Park, Khayelitsha. The address pointed out by the suspect was 19 A Morning Star Road in Khayelitsha.

The suspect Lunga Mkwasi , 22 years old of 19A Morning Star Road, Khayelitsha was detained at Khayelitsha, Site B and the members applied for a search warrant to search the storage facility. Mkwasi was detained on Khayelitsha CAS 327/05/2008-Possession of drugs. The suspect had outstanding cases pending against him as well. At 14:00 the premises were raided and found to be the big storage facilities for mandrax. Approximately 18 000 Boss

Mandrax tablets were found in one of the bedrooms that was closed. Total value at about R1000 000.00, the occupant that was found in the house was arrested in Khayelitsha CAS 335/05/2008- Dealing in drugs, Angelina Nazo, 57 years old residing at same premises.

During further follow up investigation it was established that the sister Funeka Nazo of Lunga Mkwazi was the person that had stored the mandrax. She was arrested by the Investigating Officer a few days after the raid. It needs to be mentioned that after the raid, it was established that Funeka Nazo was also registered as one of the Organised Crime Highflyers. The case is therefore being investigated by the Project Manager, Insp MM Swart of Cape Town Organised Crime.

4. RECOMMENDATIONS

This is a very good success, it does put the emphasis on members not to only arrest but they should properly interview the suspect. Due to good policing a lot of mandrax was taken off the streets and out of the community. The Provincial Panel agreed when it sat on the 23-02-2010 that the four members should be awarded R10 000.00 each and a Commendation Certificate from the National Commissioner.

This application was recommended by the Western Cape Provincial Office and it was approved by the National Head Office but the name of <u>0637672-0 WO PR Maarman</u> was omitted from the initial application and this office would like him to be awarded with cash in the amount R10 000.00 and a Commendation Certificate from the National Commissioner. The other three members were awarded R10 000.00 each and Commendation Certificates from the National Commissioner.

Sergeant S Mteyise is nominated for the award of Detective of the Year for Khayelitsha Detective Service. This member is nominated due to his continuous commitment and dedication towards his work. He has an impeccable sick record and has not booked off sick for the past three years. On average, he works 40 hours per month overtime without any remuneration, or rest days. He has a great passion towards the Detective Service.

He is currently serving as a murder investigator in the serious and violent investigation squad of the Detective Service. On receipt of a docket he leaves no stone unturned in order to identify the perpetrator (s). His dockets are usually finalized within a very short space of time. He currently has 96 dockets on hand for investigation. Fifty six (56) of these dockets is currently running court – a very high percentage indeed for murder cases.

He duly follows the Principle of Locard which states that on every crime scene a clue is left and that it is for the investigator to detect such a clue. He can be regarded as a very good team worker and is always willing to assist his fellow colleagues, even to his own detriment. He spends countless hours digging for clues without requesting any remuneration. He is an asset to the South African Police Service and serves as an example for other members.



In 2006 Khayelitsha had about 1500 fire arms on hand in the SAP 13 stores. These motivated members worked hard to reduce the fire arms and started the financial year of 2011 with 188 fire arms. At the end of the financial year 2012 there were 144 fire arms in the SAP 13. They received 146 fire arms, 38 handed over to lawful owners, 16 transferred to other stations and 96 send for destruction. As soon as a fire arm is received it is send to the ballistics for IBIS testing. Appointments are made for etching for fire arms that does not have serial numbers. Family applying for estate fire arms addressed are regularly visited to ask how far there applications are to speed up the process. No disposals in registers outstanding. Total of 12 general registers and 11 fire arm registers were carried over to the carry over registers, reduction of 23 registers for the financial year 2011/2012.

Members are performing well above there normal duties and set KPA's. During the financial year of 2011/2012 2148 exhibits was received with CAS numbers and 90 without CAS numbers. 1636 Exhibits ith CAS numbers was destroyed and 88 without CAS numbers. 492 Entries where dagga was booked was destroyed. 222 drugs were forwarded to the lab. R 92340.10 was received, R73 300.10 was deposited and R19 044.00 was handed over to lawful owners. Two (2) auctions were finalized for the financial year. No shortages or losses out of SAP13 were reported for the financial year.

These members are trust worthy, hard working and motivate each other. They are not miss using their sick leave and perform weekend duties without numerations of which they do not even take their rest days. BATHU PELE is the principal that comes first and they work very well with the community members. They also have a good work relationship with the detectives and the archive personnel. The functional member danger allowances were taken away and they had to pay back, but still not even this could affect their quality of work. Members are positive towards the work and go that extra mile to get there word done in the set timeframe.

On Saturday 2011-05-21 at approximately 17:45, the Khayelitsha Tactical Response Team (TRT) was on duty for duties within the Khayelitsha Cluster. The team was lead by Sgt Zeegers at the time. At 02:30, the following morning, they were called by the Provincial Commissioner to report at Kraaifontein SAPS.

On arrival, they were briefed in the Conference Room by the Provincial Commissioner personally who informed them that two Police Officials (W/O Mathee and Cst Cloete) have just been shot and killed by unknown suspects and two official firearms taken. The PC requested all present that the team should not rest until the perpetrators are behind bars.

We did just that and shortly after the briefing, the team linked up with Detectives from the Hawks, assigned to investigate the case (Kraaifontein CAS 1031/05/2011 Double Murder). They briefed the team as to possible suspects who could be involved or responsible for the murders. On the same day at approximately 22:00, the team officially booked-off from duty after conducting searches and following up on leads the entire time. Still they did not 'rest'. TRT members residing in Khayelitsha connected with their Informers who gave them new information. This was followed but to no avail.

As from the date of the shooting up to the 28th of May, TRT teams were following possible leads together with members from the Hawks but no progress was made.

However, on 2012-05-30, team members reacted on information received the Informer of Cst Jodo (TRT team member) who lead them to arrest one of the suspects, Khangalani Thwala @ "Kaizier", who they found at Tygerberg Hospital. The suspect was positively linked and identified as being one of the perpetrators. Hawks Detectives were informed. After they interviewed the suspect, the team managed to apprehend the second perpetrator, Sivuyile Sangovana @ Vimba". Two firearms were retrieved, being the police firearm as well as the firearm used during the police murders. Both these firearms were found in possession of Olwethu, apprehended at an address in Khayelitsha.

It was later established that the abovementioned suspects, a third suspect, Olwethu Sothandoshe @ "Odds" as well as two other suspects was believed to have been involved in Carjacking and Attempted Murder in Khayelitsha on the 21st of May, hours before the policemen had been killed. They managed to hijack this vehicle and travelled from there to Kraaifontein where the double police murder took place. Olwethu was apprehended shortly after the murders took place but he refused to divulge any information during questioning. The 4th suspect, believed to have been the driver was also arrested in Site B, Khayelitsha and assisted police with information. The 5th suspect was also arrested and charged. The suspects, mentioned by name, was later established as being the main perpetrators linked to the police shootings.

"Whenever a police member is shot and killed, it is as if it's part of you that has been brutally ripped away from you! All members are part of a family and needs to look out for each other as if it's your own family!" These members did not 'rest' until they managed to apprehend these murderers and other members should follow their example each day. Not only did the arrests result in the apprehension of police murderers but it closed many cases where these criminals took lives and robbed other people's possessions. ADDITIONAL CATCH THAT NEEDS MENTIONING

Khayelitsha Police had been searching for a High Flyer, Phindile Mhlobo @ "Pira" as well as his accomplice, Jabu Madekane, after they were involved in a double murder, attempted murder and robbery incident which took place during August 2011 (CAS 828, 829, 836, 860/08/2011).

These suspects have been involved in shooting incidents in Khayelitsha since November 2010. The main suspect, Phindile, was responsible for the deaths of 10 people since the mentioned date.

The incident in Khayelitsha originated in Kuyasa, Harare, where the suspects were involved in a house robbery. During the incident, Phindile shot and killed one of the occupants in the house and during the shootout, also killed Jabu. He fled from there, taking Jabu's firearm with him, to his own house where he was involved in another shooting incident. He tried to stage this incident in order to steer the attention away from him by shooting himself in the arm. He handed the over the two firearms to his friend to hide. He was then taken to Site B Day Hospital by community members and friends who lived close by.

Cst Mbovu received information from his Informer that Phindile had been shot and on his way to Site B Day Hospital. Another eyewitness also recognised him as being a suspect sought by police as the Investigating Officer, W/O Anton Barnard, placed photos of him all over as well as in the hospital. By the time that this person contacted the IO, the TRT team already responded and managed to successfully apprehend Phindile at the hospital.

TRT members also responded to information, after interviewing Phindile, that the firearms had been given to a friend of his. On arrival at the house they conducted a search and found the two firearms buried in the yard. The friend was also arrested but later released as he gave his full co-operation to police.

On Sunday 2011-07-17 the Khayelitsha Tactical Response Team (TRT) was on duty for duties within the Khayelitsha Cluster as from 06:00 up to 16:00. The team was lead by W/O Abrahams at the time.

The team went off duty and as most of them were about to take a rest at home, the team leader received a phone call from Colonel Kwinana (Hawks), informing him that information has just been received that one of the most wanted suspects, Sivuyile Lubobo @ "Svish", within the Western Cape could possibly be in the Paarl area and that our services were needed. W/O Abrahams called his members and regrouped.

The team drove to Paarl to follow up on information. On their arrival at approximately 18:00, they grouped in the board room at Paarl SAPS and planned an operation to track down the suspect in Mbekweni Informal Settlement where he was believed to be drinking with friends. The Informer also told them that he was positively armed. It needs mentioning that the team had no photo to run on but one of the team members, Cst Jim, saw him before and was able to recognize him, should he be spotted.

In Mbekweni, they circled the premises as planned and knew that the suspect had no chance to escape. Cst Jim recognised Sivuyile and notified the team to move in. As they moved in on the suspect, one of Sivuyile's friends, Luyanda Tyapile, who was positively armed, tried to fight off the police team. During the shuffle he fired shots towards the police and started running. He however failed to escape as the members managed to apprehend him by shooting at him whilst he tried to flee.

The members recovered an unlicensed firearm of which the serial number was removed as well as 6 live rounds.

The Western Cape High Flyer was responsible for the death of a police member, Constable Siphaza from Lansdowne Detective Services. He was shot at and killed in Khayelitsha during February 2010 (CAS 776/02/2010). He was arrested at the time but managed to escape from lawful custody at Lingelethu-West.

Not only did the arrests result in the apprehension of a police murderer but it closed many cases where this criminal took lives and robbed other people's possessions. The cases mentioned are as follows:



3. SUMMARY OF EVENTS

On 2008-05-12 the above mentioned members went on foot patrol in Site C , Bravo Block, Khayelitsha. A suspect was searched and found in possession of 61 (Boss) mandrax tablets. The suspect was interviewed properly by the members. The suspect then pointed out the storage facility in Ikhwezi Park, Khayelitsha. The address pointed out by the suspect was 19 A Morning Star Road in Khayelitsha.

The suspect Lunga Mkwasi , 22 years old of 19A Morning Star Road, Khayelitsha was detained at Khayelitsha, Site B and the members applied for a search warrant to search the storage facility. Mkwasi was detained on Khayelitsha CAS 327/05/2008-Possession of drugs. The suspect had outstanding cases pending against him as well. At 14:00 the premises were raided and found to be the big storage facilities for mandrax. Approximately 18 000 Boss

Mandrax tablets were found in one of the bedrooms that was closed. Total value at about R1000 000.00, the occupant that was found in the house was arrested in Khayelitsha CAS 335/05/2008- Dealing in drugs, Angelina Nazo, 57 years old residing at same premises.

During further follow up investigation it was established that the sister Funeka Nazo of Lunga Mkwazi was the person that had stored the mandrax. She was arrested by the Investigating Officer a few days after the raid. It needs to be mentioned that after the raid, it was established that Funeka Nazo was also registered as one of the Organised Crime Highflyers. The case is therefore being investigated by the Project Manager, Insp MM Swart of Cape Town Organised Crime.

4. RECOMMENDATIONS

This is a very good success, it does put the emphasis on members not to only arrest but they should properly interview the suspect. Due to good policing a lot of mandrax was taken off the streets and out of the community. The Provincial Panel agreed when it sat on the 23-02-Certificate from the National Commissioner.

Constable Zamani also has a goal of combating crimes against women and children and often addresses the community on these Issues through pamphlets, walk and talk campaigns, group discussions and forum meetings.
