CAUSE No. 80 OF 1986

Parties:

Kenya Union of Commercial Food and Allied Workers

and

Nararash Wholesalers Limited

Interpretation Application:

Ruling.

THE court announced its award in the above dispute on 29th December, 1987, in respect of seven grievants. The court awarded the grievants terminal benefits and two months salary each compensation for the wrongful dismissal they had suffered.

The claimants have moved the court for an interpretation of this award saying that the grievants' terminal benefits should be computed on the basis of the collective agreement that would have been effective from 1st August, 1980, for a duration of two years. The claimants informed the court that the parties had negotiated and concluded the renewal of the parties collective agreement for the period 1st August, 1978, up to 31st July, 1980. However, the respondents did not sign the parties collective agreement proposed to cover the period 1st August, 1980, up to 31st July, 1982, and it could not be registered by the court. The claimants felt that it is wrong for the respondents to calculate the grievants terminal benefits on a collective agreement that had been revised through voluntary negotiations simply because the respondents have adamantly continued to refuse to sign it to date.

The claimants requested the court to order the respondents to calculate the grievants terminal benefits namely: gratuity, overtime, leave allowance, and leave days on the basis of the negotiated collective agreement because it is the respondents who refused to sign and have it registered by the court.

The respondents in their response told the court that the present application is not an interpretation application because the claimants have failed to show what is to be interpreted by the court. The respondents further stated that the claimants have in disguise reported "refusal to sign an agreement" to the court which itself is a trade dispute and not an interpretation.

The respondents told the court that the claimants are stubbornly demanding that the grievants terminal benefits be calculated on the basis of an unsigned and un concluded agreement which documents the claimants know very well have no legal impetus before the court. The respondents further referred the court to the provisions of the Trade Disputes Act, section 13 (1) and (2) which prohibits the implementation of a collective agreement that has not been registered by the court.

The respondents concluded their submissions by telling the court that the parties last collective agreement expired on 30th July, 1980, and its terms and conditions have not been amended to date and it is still the only valid collective agreement in force between the parties. The respondents in view of the above prayed the court to dismiss the claimants demand as baseless and to award that the grievants are entitled to be paid terminal benefits in accordance with the existing valid collective agreement.

The court has carefully considered the parties submissions and finds that the claimants claim is based on the ground that the parties had negotiated proposals to amend their last collective agreement that was supposed to expire on 31st July, 1980. Unfortunately the parties new collective agreement incorporating the items they had agreed was not submitted to the Minister for Labour for registration by the industrial court.

Under these circumstances and considering the provisions of section 11 (2) of the Trade Disputes Act the court has no alternative but to reject the claimants interpretation.

THE Kenya Chemical Workers Union shall hereinafter be referred to as the claimants and Superfoam Limited shall hereinafter be referred to as the respondents.

2. The parties were heard in Nairobi on 3rd March, and 27th May, 1987 and 19th July, 1988. The court relied on the parties verbal and written submissions. In addition Opolo Omiti the industrial relations officer of the Tailors and Textile Workers Union was called as a witness by the respondents while the court on being moved by the claimants visited the respondents factory on 18th July, 1988, at Ruiru Township to see for itself the actual tasks performed by the employees in the various sections.

AWARD

3. The Notification of Dispute Form "A" dated 1st June, 1986, duly signed by the parties was received by the court on 10th September, 1986, together with the statutory certificate signed by the Labour Commissioner.

This dispute had been investigated by the Ministry of Labour and the ministry's finding and recommendation were that the respondents should continue recognizing Tailors and Textile Workers Union.

The claimants did not accept the ministry's finding and recommendation.

The court has examined and evaluated the submissions by the parties and in consideration of what the court witnessed during its visit to the factory on 18th July, 1988, is satisfied that the respondents main business is preparation of foam mattresses which involves both chemical and textile processes. The fact, however, remains that in a foam mattress the major component is foam which is realized through a chemical process.

In addition to the above the respondents have another plastic section and a knitting section.

All in all the court finds that 60 per cent of the respondents operations are chemical in nature and 40 per cent textile.

In view of the above findings the court awards that the proper trade union to be recognized by the respondents are the claimants. The court directs that the respondents should recognize the claimants forthwith and sign the recognition agreement within three (3) months of the date of the award.

The court has decided to give him the benefit of doubt and has come to the conclusion that due to this defect Mr. Ouma had no other way of expressing his total objection to this third warning letter except to crush it in his hand.

Under the aforesaid circumstances the court upholds the Ministry of Labour's recommendation of reducing Mr. Ouma's dismissal to normal termination to enable him to collect his terminal dues and further awards Mr. Ouma three months pay for wrongful dismissal.

This is the first of three annual tranches of D.kr. 20 million.
