**Before the meeting opened** Robert Hartley, addressed the Parish Council in support of the Trevornick planning application. Ben Wood from Savills also present. Sue Walters, representing Poltair, spoke in support of the Poltair Properties Ltd application.

MATTERS ARISING FROM THE MINUTES OF THE MEETING HELD ON 15th November 2017: - The clerk informed the meeting that he contacted Cormac with regard to Fly Tipping signs and has received the following reply: I cannot provide "No fly-tipping" signs, everyone knows tipping is illegal and the signs tend to have no effect.

The clerk reported that a reply has been received from Adrian Drake regarding the proposed resurfacing of Chynowen Lane – Work now scheduled for summer 2018.

The Clerk further reported that he is awaiting quotes for the repairs to the QEII park fence.

Cllr. A. Percy mentioned the need for some coppicing at the Cemetery.

Speed Camera signs – Cormac have indicated we cannot have them unless the Police put in a request.

Barnwell – it was decided to wait to January to see if any further action is to be taken.

**PA17/10853** Proposed new dwelling and garage - Land To The Rear Of Sunny Cottage, Holywell Road, Cubert Cornwall for Mr S Hackett. **Resolved:** The Parish Council already objected to the development of this area of land as it was part of a previous application for the Parc-en-Rose estate. The Parish Council now resolves to again object to the application for the same reasons. If the planner is minded to grant the application we request a condition is placed on the applicant to construct it according to the approved plans and the first floor bathroom must have obscured glass.

**SPEED CAMERA SIGNS** - The Clerk reported that a reply has been received from Cormac indicating that they will not provide speed camera signs even if funded by the Parish Council.
