<p>1. Minutes of 8 Jan 2019 meeting</p> <p>Minutes of 8th Jan meeting – proposed by Martin and seconded by Georgie, unanimously approved.</p> <p>Lizzie had circulated Draft minutes of the Dec AGM - a date correction under 'Adoption of Minutes was needed' from 2015 to 2017.</p>

Finance Update: Jan 2019</p> <table><tr><td>Income</td><td>£ 365.00</td></tr><tr><td>Expenditure</td><td>£ 98.51</td></tr><tr><td>Balance</td><td>£2,401.76</td></tr></table> <p>All allotment rents now paid</p> <p>Georgie reported that she is preparing the accounts for auditing by the end of the month.</p> <p>Regarding the electricity bill received from Scottish Hydro which was with the incorrect name, they had contacted Georgie and admitted they had made an error. With agreed tariff a new account has been set up.</p> <p>Georgie had contacted Lochaber Voluntary Action Community Accounts Service re our audited accounts but Colin received an email two weeks later saying that they no longer carried out audits. Georgie had contacted two other auditors, one of which was very over-priced but the second auditor will call back.</p> <p>Because of the above and Georgie contacting OSCR re fully accrued accounts there is another option open to the Trust which is SCIO. The Ttrust will consider but in the meantime the search for an auditor for the 2017/18 accounts will continue</p> <p>- Georgie whilst looking at possible future funding to support the Trust activities had looked at grants from the Co-op but they are not available at the moment.
