We had 3 recent reports of theft in the village over the last month, details are that on the 8th of June, some cash was taken from inside a vehicle in Asney Road, Walton. The second was theft of items from an unlocked vehicle parked on a drive in Main St, Walton and the third was a theft of an agriculture trailer, which was taken from Rogers Agri on the Ashcott side of the village.

In relation to the above, we have also had a number of theft from vehicles in and around Street as well and I am pleased to report that due to an good eagle eyed resident, Police were called yesterday and arrested a male, who was caught red handed inside a vehicle parked at Stonehill, Street. This is great news, as we anticipate that the male arrested maybe responsible for the two thefts from vehicles in Walton. The male has been charged with theft offences and is awaiting his day in court.

We have had no other reported Crime for the Walton village other than the above already mentioned but would like to stress that Police patrols have been and will continue to be in the village as much as possible when available to do so.

Traffic Police have been out and about again recently in our area, especially during the Glastonbury Festival period and I can confirm that they have been in the Street/ Glastonbury and Walton area's patrolling and dealing with anti-social driving, along with other matters such as "no insurance", speeding issues. These patrols will continue as and when they are available to do so.
