Minutes of a Meeting of Stow Bedon & Breckles Parish Council on Monday, 17 March 2014 at 7.30 p.m. in Caston Village Hall.

- 4 **Public participation session**. None.
- 5 **Minutes**. The minutes of the meeting held on Monday, 17 February 2014 were **confirmed** and **signed**.
- 6 Matters arising.
 - 6.1 [6.1 Minutes of 14 October 2013] **Drains outside Church Cottage, Breckles**. Following a complaint from the owner to Norfolk County Council Highways it has emerged that when Highways were installing a new drain they found a utility in a different location to their plans, and therefore had to relocate it. Unfortunately, in the new position the water ran neatly round the drain and continued down the road. They have now reshaped the tarmac so that the majority of the water does go down this drain. The owner has now reported to NCC that (probably as this drain is only partially effective) the drain further down the road is completely blocked. This should be cleared out by mid-March.
 - 6.2 [6.1 Minutes of 16 September 2013] **Land adjacent to Gay-Dene**. The Planning Enforcement officer at Breckland Council says that this land is now "fairly tidy," and "does not sufficiently affect the public amenity to warrant formal action," and so is closing the case.

- 8 **Council Tax Support Grant**. A letter confirming that Breckland Council will now comply with the central government directive and pass on this grant (rather than keeping it to help balance its own budget) was **received**. In the case of Stow Bedon & Breckles this amounts £51.77. Notification of this figure arrived too late for Councils to do anything about adjusting the Precepts previously served on Breckland Council.

- 9 Planning. 3AG/2014/0001 & 0002/AG: Thetford Forest Park, Breckles Heath. Applications under The Town and Country Planning (General Permitted Development) Order 1995 for Construction of new poultry arc (recte retrospective application for three poultry arcs). Notice that no prior approval is required was **received**.
- **10** Casual Vacancies. No progress. The Clerk was asked to keep including the item on future agendas.
- **Road names**. The Clerk reported that although he had written to Breckland Council asking 11 the definitive name of Rocklands Road. Lower Stow Bedon, he had received no response. He would chase this for the next meeting.
- 12 Drainage issues. An email from a parishioner voicing concerns about the East Harling Internal Drainage Board ensuring that land owners kept drains cleared was received. Councillor Pilkington said he had spoken with Peter Drake of the Board, and that he was well aware of where this work was needed. The Clerk was asked to contact the Board asking when the work was likely to be completed.

13 Finance.
