Hedley Parish Council support the proposal outlined in your letter of 2<sup>nd</sup> March last. Briefly, it is supported because of: ~ the problems associated with an out of date bridge and the amount of traffic it is expected to carry;



Thank you for your recent letter asking for support for a New Tyne River Crossing at Low Prudhoe.

This was discussed at Ovington Parish Council's meeting on 7<sup>th</sup> March and I can confirm that the Councillors are broadly in favour of your proposals for a new crossing. They felt that they could not support any suggestion of widening the current bridge as neither Ovingham, nor Ovington, as you rightly point out, would be able to cope with any increase in volume or size of traffic. # New Tyne River Crossing, Low Prudhoe.

Thank you for Prudhoe Town Council's letter of 2 March 2016 regarding the above, which was considered by Wylam Parish Council at its regular monthly meeting on 14<sup>th</sup> March 2016.

I am sorry to have to report that Wylam Parish Council felt unable to support Prudhoe Town Council's request for a new Tyne crossing. They felt that the cost of the scheme would be prohibitive: the Faber Maunsell feasibility study published in 2007 had put the cost of a new crossing at around £34 million. They were of the opinion that most heavy traffic uses the Prudhoe bypass. They also felt that a new road leading to the A69 would scar the landscape.

I wish you every success in your dealings with our local MP and the Secretary of State for Transport. £34 million is a very modest amount compared to the billions that are being spent of infrastructure in London. Please do not hesitate to contact the Parish Council again as your initiative progresses – perhaps different circumstances will elicit a different response.
