# County Cllr Anne Dale gave the following report:

- A very good democracy week event at Ovingham Middle School.
- Failed hedging at Leah Gardens, which part of a 106 agreement, is being re-done.
- Thank you for sorting the defibrillator which Mickley Social Club will arrange to be installed.
- The bus shelter on the north side will be moved across once the base has been installed.
- The planning application for holiday lets at the previous site of Mickley Golf Range brings with it more issues than presented with regards ecology, drainage and it being a site of scientific interest.
- On-going issues with gullies, parking and school transport.

### **County Clir Ken Stow** gave the following report:

- On-going issues with dog fouling and parking issues.
- Lighting at Western Avenue to Maple Grove is finally complete.
- The Bus Shelter at Eltringham is in place, following the joint scheme with the town council.
- Improved signage at Beaumont Terrace has been installed so this will hopefully alleviate the issues with lorries.
- Trees complaints on Western Avenue are the responsibility of Shenstone Housing not NCC, although Shenstone continue to deny ownership and responsibility. In some cases, residents are paying for work to be carried out.
- Both he and County Cllr Gordon Stewart have pledged money from Capital Small Schemes Funding for a pedestrian crossing on South Road.
- In conjunction with Essity, the Land of Oak and Iron and Prudhoe in Bloom, the badger has been refurbished.

### **County Clir Gordon Stewart** gave the following report:

- Hillcrest has the same issues with trees.
- Great take-up in the town with the dementia-friendly scheme.
- The Community Centre at West Wylam has a planning application to become a Dementia Day Centre; great news for residents needing this type of service, for jobs and for business.
- Eastwood Park Cricket Pavilion work has begun, Capital Small Schemes funding of £10k helped achieve this.
- Friends of Eastwood Park (FOEP) won the bid for the bowls pavilion at Eastwood Park.

Mr George Hepburn described that there was interest in operating a charity-based youth initiative as a way of bringing more funding into the town, to run alongside and supplement that offered by The East. Since the meeting seven people have expressed interest that would require a monthly commitment for the next 3-5 years.

It is expected that the initiative would operate under Prudhoe Community Partnership at first, running local activities and events and then would apply for lottery funding to employ a full-time Youth Co-ordinator. In order to set up the charity, the initiative would have to operate in the town first and the town council's funding of a detached youth service would be a great opportunity; expecting to be in a position to put this out by Easter. In the long term the initiative would be separate from both Prudhoe Town Council and Prudhoe Community Partnership, but there could be trustees from both.

The issues surrounding a Prudhoe Youth Initiative were discussed in detail and **it was AGREED** that the decision on the next agenda item would be held over until the New Year in order to allow the initiative the opportunity to take this forward.

### 1819/111 Detached Youth Service

**It was AGREED** that the proposal to seek expressions of interest in providing detached youth work sessions 'out in the town' on a Friday and Saturday evening would be held over to allow Prudhoe Youth Initiative the opportunity to take this forward in the New Year.

# 1819/115 Council Tax Support Scheme 2019/20 Consultation

**It was AGREED** to respond to the NCC Consultation on Council Tax Support 2019/20 with the following:

Prudhoe Town Council does not support the proposal which is to reduce the maximum level of support for working age applicants from 100% to 92%. This 8% reduction in council tax support will affect the poorest in our communities on the lowest income.

Although it is appreciated that economies need to be achieved, the council finds it difficult to comprehend why savings would be made at the expense of the most vulnerable financially.

The Town Council is hopeful that an alternative to this proposal can be found.
