What is the North East?

For this consultation, the North East is the area covered by the **North East Combined Authority**, a new legal body which was created in 2014. It brings together the seven Councils which serve the following areas: County Durham, Gateshead, Newcastle upon Tyne, North Tyneside, Northumberland, South Tyneside, and Sunderland. What is “Our Journey – a 20-year Transport Manifesto for the North East”?

“Our Journey” sets out a vision for the transport network that we believe the North East Combined Authority area needs to have by 2036. Our aim is to deliver affordable, attractive, reliable, safe, healthy transport choices for residents and visitors, while enhancing the environment.

At this stage, we are not aiming to include details of specific transport schemes or investment priorities, but to develop a clear idea of what a successful transport system might look like in 2036.

The consultation

We want “Our Journey” to reflect the views of residents, visitors and organisations across the North East about what the transport network should be like, which is why we want to hear your views. Please take a few minutes to answer these questions. The consultation runs until **Friday 8th April 2016**. Please ensure you return your completed form in the Freepost envelope provided so that it reaches us in good time for that date.

What will happen next

All the comments made at this stage will be taken into consideration as we develop a new **Transport Plan for the North East**. Details of the consultation for the Plan will be published widely when it takes place. The responses people give to both the Manifesto and the Plan consultations will help us make decisions on which transport projects we proceed with in future. 1. **Easy to use:** It should be easy to plan safe journeys, find out the best way to travel, pay for tickets and get all the essential information for your journey.
2. **Reliable:** The transport network should be one that we can rely on to work, with buses and trains running on time and congestion at a minimum.
3. **Affordable:** Transport should be provided at a reasonable cost relative to the journey being made.
4. **Accessible:** Transport should run as near as possible to where people live and want to travel to, and should be usable by everyone.
