**1718/PO49** Town Council Seats and Litter Bins: Cllr Greig offered to go round all the bins and seats sites to check on them and photograph them to ascertain their status. If they were not being used, they would be referred back to the full Town Council to consider removal. The Acting Clerk would accompany him. **(RG/SE)**

**1718/PO50** Damaged Litter Bin – Drawback: It was agreed to endorse the proposal as laid out in the Committee's papers: that a double capacity litter bin would replace the damaged one but sited outside Prudhoe Community School and a single bin would be placed at Drawback.

**1718/PO51** Road End Toilets: Considerable damage had been done to both the male and female sides of the toilets. No responsible persons had been identified as yet. The County Council had paid the costs of the repairs as the proposed asset transfer had not yet taken place. There was discussion on what could be done to publicise the matter and the problem of maintaining the toilets if repairs were continuously needed. Cllr Price suggested tracking the costs in detail; It was agreed that information about the damage – and the allied costs be placed on Facebook, by Twitter, onto the website and possibly as a piece in the Hexham Courant as well. **(SE)** All damages must continue to be reported to the Police with times of incidents. If the Town Council does not take over the toilets because of continuing excessive repair bills, the toilets will have to close and this should be emphasised.
