#### 1718/P058 TOWN COUNCIL SEATS AND LITTER BINS

Councillor received a copy of the Audit of Bins and Public Seats paper with the agenda for information and discussion.

Councillor Jennifer McGee thanked Councillor Russ Greig for carrying out the audit and producing the paper.

Councillors discussed the audit and it was agreed that the information in relation to the seats and litter bins owned by Northumberland County Council will be forwarded, this was proposed by Councillor Russ Greig and seconded by all Councillors.

ACTION: Councillor Russ Greig to send information to Northumberland County Council re the seats and litter bins they own.

Councillors also agreed that costings were needed for the seats and litter bins that require repair, repainting or replacement so that a tender can go out for quotes. Councillor Andy Gill advised that Northumberland County Council would be taking responsibility for the cemetery seats so these seats should not be included in the tender.

ACTION: Councillor Russ Greig and Councillor Eileen Burt to produce a tender document to include costings and bring to the November 2017 Ordinary Council meeting at the end of the month.

Councillors also discussed the seats located on The Glade and it was agreed that a letter would be sent to Northumberland County Council pushing them to repair the seats, this was proposed by Councillor Jennifer McGee and seconded by all Councillors.

ACTION: Clerk to write to Northumberland County Council asking them to repair the seats located on The Glade, with a copy to be sent to the two County Councillors.

#### 1718/P059 CEMETERY AND WAR MEMORIAL SUB COMMITTEE

Councillor Andy Gill provided an update to Councillors on the recent Cemetery and War Memorial Sub Committee and advised as follows:

- Grass cutting is now finished and now into winter maintenance;
- There had been an issue with a lady and extra planting on top of one of the graves, this
  has now been resolved:
- The chapel needed work which has now been completed and the shutters have been maintained;
- The front of the old chapel entrance and the old stone wall, which has fallen over, need repairing;
- A headstone had been put in a few months ago which no one knew about. A letter was sent to the deed holder with no reply initially, the headstone then vanished and an application to erect a headstone on the grave was received 4 weeks ago. The Cemetery and War Memorial Sub Committee have decided that they will not give the contractor the licence to work in the cemetery as the original headstone erected was unsafe. The deed holder has been informed of this decision and given details of licenced contractors;
- Costings are being looked at to tarmac the walkway to the west side of the cemetery (Bewick Grange), and work is to be also carried out to the gate at the top;
- Costings of £8,000 to be taken to the Town Council meeting for consideration.

Councillor Jennifer McGee thanked Councillor Andy Gill for his work in sorting out the issues with the lady and the extra planting on one of the graves.

#### 1718/P059 REQUEST FOR BUS SHELTER

Councillors received a copy of a request for a bus shelter at the Eltringham Road Bus Stop with the agenda for consideration.

Councillors discussed and it was suggested that West Ward County Councillor Ken Stow is contacted to look at this and ascertain if Northumberland County Council are willing to contribute towards the cost and obtain a quote to look at a plan re what type of shelter could be erected. This was proposed by Councillor McGee, seconded by Councillor Chris Cuthbert and agreed by all councillors.

ACTION: Clerk to write to West Ward County Councillor Ken Stow re costings for bus shelter at Eltringham Road Bus Stop.

#### 1718/P060 LIVE CHRISTMAS TREES

Councillors received notice that the live Christmas trees would be delivered on 14 or 15 November 2017 and it was agreed that they would be installed at The Glade, Mary Magdalene Parish Hall and Mickley First School. Proposed by Councillor Jennifer McGee and seconded by all Councillors.

ACTION: Clerk to write to Northumberland County Council to obtain a quote for the installation of the Christmas trees.

Councillor Jennifer McGee advised that there have been issues with the Christmas lights due to scaffolding currently being erected. The company have been contacted to ask if the scaffolding can be removed prior to the Christmas trees and Christmas lights being installed.

#### 1718/P061 EASTWOOD PARK PLAYING FIELDS

Councillor Russ Greig discussed the work being carried out at Eastwood Playing Fields and advised that this is all being completed in stages. A meeting needs to take place with the Town Council, Northumberland County Council and the football club to discuss the work that still needs to be completed and funding to carry out this work.

Councillors discussed and it was proposed that Mike Jeffries, Sam Talbot, County Councillors and the football club are contacted to arrange to meet and formulate a programme of works to move this forward as the Town Council are keen to make a contribution for this work. This was proposed by Councillor Eileen Burt and seconded by Councillor Glenn Simpson.

ACTION: Clerk to contact Mike Jeffries, Sam Talbot, County Councillors and the football club to arrange to meet and formulate a programme of works to move this forward.

Councillor Glenn Simpson suggested reviving the old group which previously met to move this work forward.

Councillor Russ Grieg suggested contacting the new administration re possible transfer of assets which had been refused by the previous administration.

Councillor Russ Grieg advised Councillors that security cameras are to be installed in the play area to monitor anti-social behaviour following a recent complaint.

Councillor Jennifer McGee made Councillors aware of a petition which has been started for a skateboard park in the area.
