## Statutory Consultation: Proposed Off-Street Parking Order 2019

In accordance with The Road Traffic Regulation Act 1984, The Local Authorities' Traffic Orders (Procedure) (Scotland) Regulations 1999 and as instructed by the meeting of Aberdeenshire Council on 17 January 2019, please find enclosed information relating to proposals for changes to the Off Street Parking Order including Schedules.

The reason for the changes to the wording within the Order is to address issues which have arisen, technological changes or unnecessary procedural detail that have come to light since the last revision. The changes to charges are to address an ongoing budget deficit of £244,000 per year, encourage longer dwell time in town centres to support economic activity and reduce confusion of differing charging periods and tariffs.

The proposed changes are attached. #### **Detail of changes**

This Consultation is on changes to the following Off Street Parking Orders:

- > The Aberdeenshire Council (Banff and Buchan) (Off-Street Parking) Order 2014
- > The Aberdeenshire Council (Buchan) (Off-Street Parking) Order 2014
- > The Aberdeenshire Council (Garioch) (Off-Street Parking) Order 2014
- > The Aberdeenshire Council (Formartine) (Off-Street Parking) Order 2014
- > The Aberdeenshire Council (Kincardine and Mearns) (Off-Street Parking) Order 2014
- > The Aberdeenshire Council (Marr) (Off-Street Parking) Order 2014
- > The Aberdeenshire Council (Oldmeldrum) (Off-Street Parking) Order 2014

These are to be replaced with a single 'The Aberdeenshire Council (Off-Street Parking) Order, 2019'.

The area based Orders were introduced to allow for more flexibility to adapt car parking regimes to local needs. In practice this has caused confusion for the public and unrest between communities.

The changes to the content of the Order is as follows

### 1) Article 2

- a. Wording altered for definition of "Cashless Parking".
- b. Definition of "ticket" has been altered to allow for virtual tickets issued by electronic means.
- c. Definition of "blue badge holder" amended to take account of updated legislation.
- d. Addition of definition of "initial charge".
- e. Addition of definition of "pool car".
- 2) Alteration of wording in Article 3(1) to include reference to Article 17.
- 3) Deletion of Article 4(5) "If a ticket issued by the ticket issuing machine is obtained for the vehicle by payment of the initial charge or is in respect of a free parking period, the ticket shall be exhibited on the vehicle, in accordance with the provisions of Article 4. No other ticket issued by a ticket issuing machine shall be exhibited on the vehicle."
- 4) Addition in revised Article 4(5)(b) to state that the correct vehicle registration is shown on the ticket, for the vehicle which is parked.
- 5) Article 5(1) deletion of reduced payment rates for Excess Charge Notices. These have been removed from being detailed within the Order and will instead be covered by separate associated guidance.
- 6) Article 5(2) addition of wording to accommodate for Excess Charge Notice to be handed to driver.
- 7) Article 5(2)(c) wording regarding reduced payments deleted.
- 8) Article 5(3) addition of details on the process followed should a vehicle drive away, or refusal of the excess charge to the vehicle or handing to the driver.
- 9) Insertion of a new Article 7 covering appeals of Excess Charge Notices.
- 10) Deletion of previous Article 10
- "No Additional Coins to be inserted after Payment of Initial Charge

Persons wishing to park for more than the minimum charge period must make payment of the appropriate charge at the time of first parking"

- 11) Article 11(1) deletion of "and subject to the approval of the relevant Area Committee"
- 12) Insertion of Article 11(2) "Changes to zoned areas will be subject to approval by the relevant Area Committee"
- 13) Article 11(6) deletion of "There shall be endorsed on any residential exemption permit the vehicle registration number relating to the vehicle for which the permit was granted, and" with remaining text changed to read "Any residential exemption permit shall be valid only in respect of the vehicle that the permit was issued for."
- 14) Article 11(7) deletion of "thirty pounds from 1 June 2014, forty pounds from 1 April 2015, fifty pounds from 1 April 2016 and" and date of 1 April 2017 to be changed to reflect date new order will come into place. Addition of "The cost of residential exemption permits shall be subject to review."
- 15) Deletion of previous Article 11(9) "The Council will maintain a database of all residential exemption permit holders pertaining to off-street car parks."
- 16) Alteration of wording in Article 11(10) from:

"Residential exemption permits are not required to be displayed."

to

- "Residential exemption permits will be electronic and will not be required to be displayed."
- 17) Insertion of Article 11(11) & (12) as follows:
  - (11) All residential exemption permits shall be issued at the discretion of the local authority and any refusal will be issued in writing with accompanying reasons.
  - (12) Any decision to refuse a residential exemption permit may be appealed in writing and will be subject to the appeals process outlined in guidance produced by the local authority.
- 18) Article 12 amended from:

## "Traders Exemption Permits

- (1) An application for a traders exemption permit can be made to the Council in writing by traders. Applicants must demonstrate that:-
  - (a) they provide a service that is not currently provided by shops in the local town centre.
  - (b) there is persistent difficulty in getting parked on the streets in the local town centre.
  - (c) there is parking available in the local town centre car parks.
- (2) A traders exemption permit shall be payable at a cost of two hundred and fifty pounds per annum and will permit commercial activities to be held by traders in off-street car parks in specified towns."

to:

## "Traders Exemption Permits

- (1) An application for a traders exemption permit can be made to the Council in writing by traders. Applicants should meet the general principles of;-
- (a) provision of a service that is not currently provided by premises in the local town centre.

- (b) there is persistent difficulty in getting parked on the streets in the local town centre.
- (c) there is parking available in the local town centre car parks.
- (2) Applications will be determined in accordance with guidance produced by the local authority.
- (3) A traders exemption permit shall be payable at a cost of two hundred and fifty pounds per annum per car park (where charges apply as specified in the Schedule to this Order) and will permit commercial activities to be held by traders in off-street car parks in specified towns.
- (4) The appropriate officer of the Council shall require sight of any suitable documentation in connection with the need to determine whether or not an application to hold a traders exemption permit is eligible to do so.
- (5) In the event of failure to produce the necessary relevant documentation then the Council shall be entitled to refuse to issue a traders exemption permit for that person.
- (6) Traders exemption permits will be electronic and will not be required to be displayed.
- (7) All residential exemption permits shall be issued at the discretion of the local authority and any refusal will be issued in writing with accompanying reasons.
- (8) Any decision to refuse a residential exemption permit may be appealed in writing and will be subject to the appeals process outlined in guidance produced by the local authority."
- 19) Article 13 amended from:

"Manner of Standing in Off-Street Car Parks

Every vehicle left in an off-street car park where stalls are marked shall only use that off-street car park by parking within a stall, and shall so stand that every part of the vehicle is within the limits of that stall."

to:

## "Manner of Standing in Off-Street Car Parks

- (1) Vehicles, including motorcycles, left in an off-street car park where stalls are marked shall only use that off-street car park by parking within a stall, and shall so stand that every part of the vehicle is within the limits of that stall.
- (2) Where the vehicle is larger than the stall an exception will be made providing the vehicle is still parked considerately.
- (3) Exceptions will be made for Blue Badge Holders parked within standard bays to allow users additional space to fit their needs."
- 20) Article 14(3) "displaying" changed to "holding"
- 21) New Article 14(4) inserted "Any vehicle with the permission of any person duly authorised by, or on behalf of, the Council."

22) Deletion of previous Article 8 "No person shall operate any audio equipment either in or outwith a vehicle while in an off-street car park."

23) Amendment of Article 17(9)(d) from:

"use a skateboard, or roller blades, or suchlike."

to

"act in an antisocial manner such as to cause alarm or distress; or"

- 24) Insertion in Article 17(9)(e) of "hold or permit to be held upon the premises any political canvassing or meetings."
- 25) Article 20(1) amended from:

"An annual list of local events shall be agreed by the relevant Area Committee to be held in specified off-street car parks and requiring the suspension or reserved use of the car park."

to

"An annual list of local events to be held in specified off-street car parks and requiring the suspension or reserved use of the car park shall be circulated to the relevant Area Manager and Ward Members."

26) Article 20(2) amended from:

"For all other events including one-off events any person duly authorised by the Council may suspend or reserve the use of an off-street car park, or any part thereof, whenever and for such period as is considered reasonable and shall duly inform the local Ward Members and the Chair of the relevant Area Committee."

to

"For all other events including one-off events any person duly authorised by the Council may suspend or reserve the use of an off-street car park, or any part thereof, whenever and for such period as is considered reasonable and shall duly inform the local Ward Members and the relevant Area Manager."

27) Article 22(2) amended from:

"The Council may reserve in any of the car parks affected by this order a suitable number of spaces for vehicles displaying in each case a disabled person's badge issued by a local authority in exercise of its powers under Section 21(1) of The Chronically Sick and Disabled Persons' Act, 1970, and no person shall cause or permit any vehicle to wait in such a space, at any time, without displaying such a badge."

to

"The Council may reserve in any of the car parks affected by this order a number of spaces for the charging of electric vehicles. An electric vehicle may only be left in a space reserved for such vehicles during the period taken to charge the vehicles battery. An appropriate ticket will be required where the space reserved is within a car park where parking restrictions or charges apply."

- 28) Addition of Article 22(3) & (4) as follows:
  - (3) The Council may reserve in any of the car parks affected by this order a number of bays for use by Pool vehicles. Pool vehicles must be registered electronically with the appropriate officer of the Council. Any pool car bays are only to be used by the registered pool vehicles.
  - (4) The Council may reserve in any of the car parks affected by this order a number of bays for use as loading bays, coach/bus parking, motorcycle parking, lorry parking or any other specified reason.
