Internal audit is the periodic independent review of a council's internal controls resulting in an assurance report designed to improve the effectiveness and efficiency of the activities and operating procedures under the council's control. Managing the council's internal controls should be a day-to-day function of the staff and management and not left for internal audit.

The council is required to take appropriate action on all matters raised in reports from internal and external audit and to respond to matters brought to its attention by internal and external audit. Failure to take appropriate action may lead to a qualified audit opinion.

To the Chairman of the Council:

I met with the Clerk & RFO to the Council, Mrs Katrina Jones, to carry out the annual internal audit. My thanks to Mrs Jones for her hospitality.

I conducted a detailed scan of the minutes and examined the accounts, bank reconciliations, internal controls and the year end procedures.

Through these examinations, hard evidence and questioning I tested all areas of management and the delivery of the councils business and functions and am pleased to report that I have found no issues.

I advised the Clerk that the Council is holding quite a large reserve balance, if the council is holding a reserve balance in excess of its precept amount it is advisable to minute that these funds are earmarked for specific projects rather than just being part of the general reserve.

This report is based on the evidence made available to me. It would be incorrect to view internal audit as the detailed inspection of all records and transactions of a council in order to detect error or fraud. Consequently, the report is limited to those matters set out above.
