1. Previous Minutes

2. Matters arising

1. From Item 2. Highland Small Communities Housing Trust NC followed this matter up further with Steven Gregg from the Trust.

Actions from December meeting

2.1.1 HSCHT study costing

NC had received a quotation for the Housing Needs Survey from HSCHT. The quotation received is £ 2804.00 + VAT = £3364.80

2.1.2 NC also to enquire whether Ward funding could be available Di Agnew (Ward Manager) has advised that funding is not available this Financial Year but that we should apply for funding from the 17/18 budget and she has indicated that there is a good chance of support. The meeting agreed that NC should apply for £2500 funding from the Ward Discretionary Fund. **Action NC**

2.1.3 It was agreed that a general question should be in the survey on anything else people would like to see in the community.

NC has submitted the wording provided by Sally-Ann Jackson on 08.12.16 to HSCHT as follows:

'Is there anything in the Resolis area that you would like to have provided which would really improve the quality of your life here?'

2.1.4 HSCHT have suggested that it would be good if we could get funding support from local employers.

NC will also apply to SSE to see if they will give any support.

- **2.1.5 Affordable Housing for elderly.** HSCHT have also asked if we would like to add a question to help assess the affordable housing needs of more elderly residents The meeting agreed that NC should discuss adding an appropriate question to the survey.
- **2.2.1** From item 3, Treasurers Report. Donation to Resolis School. MC had received a receipt.

2.5.1 From item 5. Cromarty CC would like the support of Resolis CC on resistance to the ship-to-ship oil transfer proposal.

A second consultation exercise was understood to be underway. The meeting considered the main issue was the proposed location rather than the transfer operation itself. NC to monitor.

- **2.6.1 From item 6 Planning.** Application the Newhall Steading. NC had put a supporting comment on the planning web site, including concern about careful design of the road junction at Newhall corner.
- **2.7.1 From item 7. AOB**. Traffic speeding in Jemimaville. NC had received a response from Carl Sandever (Police) that initial approach should be made to Highland Council. NC to progress.

2. Newhall Bridge
