1. Previous Minutes

At item 2 reference was made to a proposed development at Newhall Farm. It should have read Mains of Newhall Steading.

2. Matters arising

Actions as follows:

- 1. From Item 1. It was noted that the new Meals on Wheels service had started recently.
- 2. From Item 2. Carried over from last meeting, NC to contact Philip Waite to establish the outcome of his investigation and actions regarding access to the development at Newhall Farm.
- 3. From item 2. NC had reported the pothole issues on roads. Some repair work had been carried out but in many cases the potholes reappeared very quickly, possibly due to tractor traffic and other heavy vehicles. Larger area resurfacing was more effective. Also the new jet patcher had been seen in operation locally.
