- Newhall Access It was suggested asking Phil Waite about it being a right of way.
- Meals on Wheels run by B.I.C. due to start in March food to be made by local restaurants.

Councillor's Report

- D.A. said there were severe cuts in the latest budget with 280 staff due to leave and some services to go.
- The ship to ship oil transfer proposal for outside Cromarty Sutors:— As yet, it appears that there is not enough evidence to allow it to go ahead without further investigation it is now down to the coastguard agency to further consider the issue of the discharge of ballast water.

Any Other Business – Potholes need to be reported to the service point.

Planning – A planning application has been submitted for a second temporary Newhall Bridge so that traffic can be diverted to allow the permanent structure to be built. No issues raised by RCC

3. Treasurers Report

MC issued a cheque for £200 for Secretary Honorarium and reported that Hall fees of £75 had been paid covering the period February to June 2016 NC advised that we had received an e-mail notifying us of the Community Council Grant for 2016/17. It was noted that grant levels were reduced this year due to Council cuts. The Grant for Resolis is £942.78 before the insurance charge, a slightly lower figure than last year.

4. THC Councillors report

DA reported that the sale of Newhall School had fallen through again late in the process. The reason was not known but uncertainty about dealing with the drainage issue was the most likely reason.

No other Council business was reported.

5. Correspondence

- NC had circulated a consultation questionnaire regarding local policing. The form was discussed and the biggest issue was speeding, particularly near Balblair and through Jemimaville. No other notable issues. Action. NC to complete and return the questionnaire.

NC had received information from the Highlands Small Communities Housing Trust (HSCHT) which notified that funding assistance was available for developing affordable housing in rural areas such as Resolis. Newhall School playing field site was discussed as a possible site and The Community Council acting with a (not for profit) Housing Association could access the funding. Action. NC to make initial contact with the Council (Alan Maguire) and the HSCHT to discuss.
