Nairn Town and County Hospital 1906

By the end of the 19th century, Nairn Town & County Hospital building was well past its best and a committee was formed in 1899 to consider the whole question of hospital accommodation. The 1901 annual report considered the building 'antiquated in construction and equipment' and a hope was expressed for a new hospital.¹ At the Annual General Meeting of 1902, it was agreed to pursue a new building and a committee of ladies to publicise the financial needs of the hospital was formed. By then, donations were being received for the new building.

In 1903, a public appeal was underway when the costs of the building, £4,000, were offered by Mr Alex Mann of Guayaquil, Ecuador who made the donation the following year.² 'He did this with the wish that his name would appear nowhere on the hospital; not even a plate (plaque) was to be inscribed with his name inside the building'. However, he was not reclusive and his generosity to this and other community concernsⁱ was well appreciated by the Nairn public at the time. He involved himself in

arrangements for the new hospital. He wrote that he was due to return home and, according to the managers' wishes, would either supervise the hospital build or just donate the money. He stipulated that it be named Nairn Town and County Hospital and that 'no native of the town or county of Nairn, whilst a patient in said hospital, shall be considered as a recipient of charity, but that his or her residence therein shall be considered his or her inborn right'. He continued to donate 10 guineas annually for some years after.³

Alex Mann (1857-1916) was the third son of Nairn's former provost Alexander Mann. He left Nairn around 1878 to train as an engineer in the Inverness locomotive workshops. He emigrated to Ecuador via England and established a large business employing many and which included importing machinery. He donated a Christmas treat for Nairn poorhouse residents for several years and funded a new bell for the parish church. In 1903, he co-founded the general Hospital de Niños Alejandro Mann in Guayaquil, later a paediatric hospital and later renamed the Dr. Roberto Gilbert Elizalde Children's Hospital. He retired to Welcombe, Hatherly Road, Kew Gardens where he died.

The Directors worked with Mr Mann to find a site, initially choosing one on Merryton Hill next to the railway bridge but later Mr Mann purchased outright, for £1,000, a four acre site of Millbank land at the Market Stance on Cawdor Road. By May 1904, the preparatory work had been done on the site and the directors were ready to receive the £4,000 and start building, which duly happened. By 1906, the new 16 bed, pavilion style Town and County Hospital building on Cawdor Road was in place. The architect was William Mackintosh of Inverness and the trades are shown on the next page. They were local unless noted otherwise.

There was a front door for patients and one for the public - each opening into a separate hall. The patients' hall opened into the surgery. The public hall led to the surgeon's, matron's and nurses' rooms. On the first floor there were the operating theatre and two large wards. There was a mortuary at the back.⁵

The hospital was unfurnished when it was opened by the Earl and Countess of Cawdor on Wednesday 15th August 1906.⁶ The problem was one of insufficient funds and the opening day - opened by Brodie of Brodie - was the start of a three-day fund raising bazaar which raised an impressive £1,470.⁷ The bazaar had a long list of patrons and stalls were organised by a veritable *Who's Who* of prominent local ladies including the Countess of Leven and Melville, the Countess of Cawdor, Lady Eleanor Brodie of Brodie and Dowager Lady Dunbar of Boath. Matron, Miss Wood, also ran a stall. Patients were eventually transferred from the old building in November.

Until 1903, the hospital had no ambulance. That year an 'old cab' was gifted by a local hirer and replaced, in 1907, by a specially adapted horse cab which could take a patient and attendant and was specially sprung to try to reduce the jolting which often badly affected patients being transported. It was handed over by Dr Cruickshank on behalf of an 'anonymous lady'. By 1920, this was showing its age. However, in 1916, a motor ambulance, the 'Nairn Town and County Ambulance' had been donated for the wartime use of the 51st Brigade on condition that it was returned for use by the hospital after the war. This duly happened and the redundant horse ambulance was then used by fever patients.

Later, the Town and County had access to two ambulances. One was provided by the Red Cross and the hospital still had its own one for which patients were charged at 1 shilling per mile in the 1940s. In the late 1930s, the ambulance appears to have made fewer than 30 journeys per year. These were mainly to the Town and County with the occasional journey to Balblair Home or to the Royal Northern Infirmary although there were several journeys further afield such as to Aberdeen.

In-patient numbers remained at 100-150 annually but were gradually increasing by the 1920s as were out-patient numbers (table above). The

table below gives an annual snapshot of how many beds were used which, were well below its capacity of 16 beds although it must be remembered that there would ongoing variations in admission numbers.

In 1911, as well as matron, there were 3 nurses, maid, cook and porter/gardener resident on census night. It is likely that two of the nurses would have been probationers (trainees). 10 years later the census details one staff nurse and one probationer but, by 1923, this had increased to four nurses.²⁰ Local doctors continued to give their services free.

By the 1920s, many Scottish voluntary hospitals had large waiting lists although Highland hospitals were often underused, and, by the 1930s, many were struggling financially. This does not seem to be the case for Nairn which seems to have been a well-managed, prudently financed, voluntary hospital throughout its history. The hospital's finances seem to be typical of other local hospitals. As the table above shows, half the income came from the community either as subscriptions or regular church collections. The other half came from rent and interest – the result of past donations or legacies which were saved – but note the substantial amount which came from private patients who paid a fee for

an enhanced such as a separate ward. As it happened, the year to May 1915 saw an income of £580 exceeded by an expenditure of £693 the deficit being made up either by years of surplus or by eating into capital.²¹

However, it must be said that the managers did not invest heavily in facilities or attempt much ongoing expansion. The hospital seemed to progress quietly and steadily, except when there was the occasional need for improvement, often funded by a donation or fund raising event.

In 1907, Chairman JS Robertson handed over an X-ray machine on behalf of Lord Cawdor²² and, in 1913, two pavilions or sun parlours were donated in his memory. There was one at each wing for male and female patients and they were intended for convalescent patients or as overflow from the wards. That year, central heating was installed. The late 1920s saw an appeal for £1400 to upgrade facilities, in particular to instal electric light and upgrade the X-ray equipment, and there was much local fund raising. In 1928, the new X-ray machine was partly funded by a fete at Newton, now a hotel but then the home of Colonel Findlay. In 1938, the hospital connected to mains electricity and its redundant generating plant was sold. The late 1920s are a supported by the support of the late of the lat

Hospital finances were not always straightforward. In 1883, apparently through a legacy, the hospital acquired a bond over property at 15 Union Street and 54 & 56 Society Street Nairn. The bond was redeemable on a loan repayment but an attempted resolution in 1890 apparently failed. The hospital received rent on the properties from at least 1905 and, in the 1930s, had tenants at 54 & 56 Society Street (3 each), 3 Wilson Street (2 flats), 5 Wilson Street (2 flats) and 6 Wilson Street (4 flats). In 1938, 56 Society Street was condemned, the tenants being re-housed by the Town Council until the buildings were repaired. By 1943, the properties were in a poor state and the Council wished to purchase and upgrade them. The hospital tried to resolve the bond with one of the two

remaining heirs but this was apparently unsuccessful and, by 1951, when the Council wished to partly demolish the Society Street house, the hospital board had no longer an interest. It had not received rent for years and the property now had squatters resident.

Finance seems to have been reasonably healthy in the 1930s with around £11,000 in investments.²⁷ Income and expenditure were each around £2,000pa with generally a surplus. However, costs were rising and, in 1937, expenditure exceeded income by around £700. Donations continued steadily and were mostly fairly small although there were some large ones (see table on page 10).

In 1931, £4,350 was received from the estate of Andrew Morisonⁱ of Northland, Waverley Road.²⁸ The hospital directors noted that a 'Midwifery Ward' had been proposed in the 1906 hospital but never implemented and they agreed to use the bequest for a maternity wing. By August that year, plans were drawn up and the building work started. However, costs were £5,460 and an 'Appeal for £1,800 for the 'Erection & Maintenance of Maternity Wards' was made. Although less than this was raised, the extension was opened in September 1932 by the Earl and Countess of Leven and Melville. The architect was Mr Bennett Mitchell of Aberdeen.²⁹ It consisted of a four-bed general ward, a private ward, a labour ward, night nursery, doctor's room, nurses' quarters and kitchen.³⁰

Maternity became particularly successful. The table on the next page shows births steadily increasing to 121 in 1947 when 53% of all Nairnshire births occurred in the hospital. The private ward attracted about 10 births per year and between 1936 and 1941 over 12% of maternity patients were from outwith Nairn, mainly from Moray. In 1946, an extension to the maternity ward was planned, and a legacy of £13,000 was received for that purpose but it does not seem to have been built.³¹

Hospitals often had long serving officers. In 1937, JS Robertson resigned from the board after 50 years of service, 35 as chair. In 1948, Alexander Robertson retired having been secretary since 1891.³² When Dr Sclanders died in 1913, he had been medical officer for 50 years and Dr George Wilson, medical supervisor until at least 1945, died aged 80 in 1948 apparently still at work.

From the table on the next page it can be seen that in-patients numbers remained steady in the 1930s but increased post war. Elsewhere, outpatients numbers increase when specialist clinics start. No records have been found of specialist visits to Nairn but, elsewhere in the Highlands, these began in the 1930s. Nairn may have been later, however, because it was not part of the Highlands and Islands Medical Service which was instrumental in promoting specialist visits to cottage hospitals. By 1943, the new Raigmore Hospital's orthopaedic surgeon had monthly clinics

and, by the mid-1940s, 'surgical' included 15-20 orthopaedic patients per year. 50-60% of all operations were classified as 'major'. There were also tuberculosis clinics and, from 1945, ante natal and gynaecology. The hospital continued, on average, a little over half full and patients stayed around 18 days. There were 15-20 private maternity patients per year who, in the 1940s, were charged 6 or 7 guineas per week, £1 more than non-maternity private patients.³³

By the 1940s, running costs were rising steadily but increased income ensured that the hospital, on average, broken even financially. It is generally thought that voluntary hospitals lost donations when the prospect of nationalisation materialised. However, Nairn hospital continued to attract funding with ongoing subscriptions, church

collections and almost £2,000 in legacies in 1944-45 and over £3,300 in 1947-48 which lifted investments from around £14,000 in 1942 to over £23,000 at the hand over to the NHS in 1948.⁵⁷ It was common practice to donate money to 'endow' a bed.¹ Legacies endowed the 'Ranza' bed in 1944 and the 'James and Nina Helen Bonalla bed' in 1946. In 1945, a gift of £1,000 endowed the 'Mrs Mary Mackay of Glebe End, Nairn' bed.⁵⁸ Legacies made to the voluntary hospital were often realised by the new hospital board. In 1952, the property of Albert Villa which has been willed to the hospital in 1944 became empty and it was sold for £2,100.¹¹

In a report issued in 1946, the hospital was described as a small hospital in a two-storey stone building on a four acre site. There were 16 general beds in 6-bed wards or single rooms; a small operating theatre; five maternity beds; labour room; fixed X-ray unit; improved out-patient department; rather inadequate nurses' quarters; all main services; central heating; small hand laundry (some laundry sent out) and mortuary. The report recommended providing out-patient accommodation⁵⁹ and fund raising for this had started in 1945. In 1946, building started on facilities which included new X-ray, out-patient theatre and physiotherapy unit. The architects were JB Nicol, Aberdeen and, later, Mr Hall of the Health The masons were Birnie of Aberdeen but Cruickshank the joiners, Burnett the slaters, and plumbers Tait and Ross were all from Nairn. 60 It cost £12,000, including £2,000 on X-ray facilities, and, after some delay, was opened in November 1950 by Colonel Cameron of Firhall. The new out-patient facility was the first hospital building to be opened under the new Northern Region Health Boardiv but also the last main act of the voluntary trustee body which had run the hospital effectively for just over a century and, on 3rd July 1948, Nairn Town and

County was handed over to the Northern Region Health Board in good heart and with sound investments.

Many doctors have been associated with Nairn Hospital. From 1847 on, the trustees normally appointed 3 local doctors as honorary medical officers one of whom was medical superintendent or supervisor. In the 1930s, Dr D MacDonald was medical supervisor, in the 1940s it was Drs Eric and George Wilson and, during the 1950s, first Dr Innes then Dr King held the post being replaced after his death by Dr MacFadyen in the 1960s. The move to a regional health service created adjustment difficulties for local GPs who formerly had a free hand in treating their patients. Patients admitted to Nairn hospital now came under the care of specialists and the hospital medical superintendent. From 1949, this caused some concern to local GPs when they could not see to their patients especially when admitted to the maternity ward.

From the late 1940s, the lack of hospital space meant that nurses were boarded at nearby Redheugh, a private house. The need for a nurses' home was noted in the 1948 annual report and an extension was planned soon after. However, it was not until May 1964 that a new seven bed nurses' residence, financed by endowment funds, was opened by Mrs Campbell of Auchindoune a former chair of the hospital board.

The gardens continued to be used for vegetable production with a full time gardener post created in 1953 in addition to the general handyman (who had previously also done the gardening). A new gardener's bungalow was completed in 1953.

General medicine increasingly dominated as specialist cases were taken to Raigmore Hospital. Surgical procedures ended in 1962, the operating theatre becoming the staff dining room. Specialist obstetrics had ceased by the early 1970s. From 1951 until the 1970s, it is listed with 25 beds and with 26 beds by the late 1980s, although it seems to have normally had spare capacity (table on next page).

In the early 1960s, births had been around 100 per annum but numbers had halved by the late 1960s and, in 1972, there were only 16 births.⁶¹ In 1985, the Health Board planned to re-designate seven maternity beds as geriatric but a campaign to retain maternity beds in Nairn forced a delay until the new maternity ward was opened at Raigmore in early 1988. In late 1988, the possibility of taking maternity cases from Moray again delayed a decision. In December 1990, the Board sought the Secretary of State's approval to close the maternity facility. He agreed in July 1991 and the maternity unit became day care for the elderly.⁶²

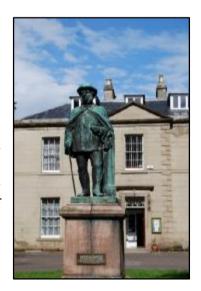
In 1992, a new day room costing £22,000 was formed with the Friends of Nairn Hospital raising £8,000. Two nurses ran in the London Marathon to raise money.⁶³

The hospital is now a GP managed community hospital for patients requiring medical care or who are recuperating.⁶⁴ In 2010, the hospital was virtually rebuilt (photo next page) and contained GP surgeries, social work, paediatrics, mental health, pharmacy and NHS dentistry making this one of the most advanced community health care facilities in Scotland.

The doctor most often associated with the 19th century Nairn Hospital is Dr Grigor who epitomises the Victorian medical man. Born in Elgin, he moved to Nairn early in his career and did much to advance Nairn as a Victorian health resort. Although not the prime mover, he was very influential in establishing the first Nairn Hospital. He is rightly commemorated by the people of Nairn in a statue outside one of its most elegant houses at Viewfield, now the home of Nairn Museum.⁶⁵
