Most poorhouses in Scotland were formed after the 1845 Poor Law which established Parochial Boards to administer poor relief in each parish, a function previously carried out by the Kirk. Poorhouses had to have 'proper arrangements for dispensing and supplying medicines' and could 'nominate and appoint a properly qualified medical man' to regularly visit poorhouses. After 1848, this was supported by a medical relief grant which assisted Boards to provide medical aid to all paupers in the parish. In the poorhouse, medical officers assessed inmates for fitness to work but, since many paupers were sick and infirm, poorhouses, in effect, became partly hospitals for the chronic sick. No medical records appear to have survived from the Skye Poorhouse but we do have some information on numbers of sick as shown below. It appears that it was normally the Portree Parish Medical Officer who attended the Poorhouse.

Parochial Boards continued the tradition of supporting the poor at home or in cottages but there was government pressure to build large poorhouses and the Skye parishes formed a combination or unionⁱ in 1852 and had their plans for a poorhouse approved the same year.² In 1859, they began to build the Skye Union Poorhouse with Ross and Joassⁱⁱ as architect.³ It is thought to have been a T shaped building - partly single storey - with a a separate laundry and small mortuary (see photograph above.⁴ Poorhouses in Scotland were run in a similar way to prisons. The Governor's authority was absolute and early poorhouses were initially often bleak, inhospitable places with basic accommodation and food although, by 1900, many were being described as more comfortable. Although no descriptions of life in the Skye poorhouse seem to have survived, there is no reason to suppose that it was any different from others.

The poorhouse appears to have opened after June 1861. That month, a large advertisement appeared for furnishings and clothes, including 20 double and 30 single beds, indicating an optimism about inmate numbers which was not realised for very long.⁵ The photo at the top is from around 1920⁶ and, although it has been extended and heightened, the original building can still be discerned in the photograph below from 2011.



The Skye poorhouse could accommodate 51 residents but was little used as can be seen from the table below. In 1870, it was said that many would rather starve than enter the poorhouse and that residents included the old and infirm as well as widows and mothers with illegitimate children. In 1878, Stornoway Parochial Board wished to send their paupers to Portree which may have augmented numbers of residents but this was not allowed by the Board of Supervision because it considered Lewis was too far away to monitor those whom they sent.

In 1890, a description appeared in the press. The writer had been shown round by the 'lady in charge.' It was clean and bright but only had seven or eight inmates and there were two empty wards of 12 beds each which had never been used. The writer made a strong case for it to become a hospital noting that the Gesto was the nearest. Strangely, although the writer makes a strong case for it receiving fever cases, he makes no reference to the Ross Memorial Hospital. The article was signed by R.McN which seems suspiciously like Dr Roger McNeil who was medical officer to the Gesto at the time. A note in the next edition of the newspaper – designed to correct the article - states that there had been 34 paupers at one time in the poorhouse and that the highest annual daily average had been 28.9

In 1892 there were never more than 12 inmates and the Board of Supervision agreed to the Portree Parochial Board request to use it for emergency cholera accommodation on the condition that there was alternative accommodation for the inmates. There is no record of the poorhouse being ever used for this but presumably it saved the local authority the expense of building and maintaining and emergency hospital.¹⁷

In 1915, the Skye District Committee was seeking hospital accommodation for tuberculosis patients who, at that time, were being sent to the Citadel Hospital in Inverness. The unused smallpox hospital at Stein was thought unsuitable and the following year it was proposed that a ward at the poorhouse be converted into two tuberculosis wards. Such was the bureaucracy of the time that the District had to negotiate with the Parish Council which ran the poorhouse and which, in turn, had to consult the supervisory Local Government Board in Edinburgh. During 1916, the financial arrangements were finalised and the first patient was admitted to the ward in January 1917 although alterations were not finally complete until May. There is no reference to nursing and it is probable that, given the low numbers in the poorhouse, it was done by the matron. This arrangement continued throughout 1918 but, by January 1919, the ward was standing empty and there is no more reference to tuberculosis patients except that the advertisement for Governor and Matron in April 1919 still included attending the phthisis ward.18

By the early 1920s at least, the poorhouse was known as Cruachan House. This change of name would be in common with many other poorhouses in an attempt to reduce the stigma of the term 'poorhouse' for residents especially when it occurred on a birth certificate.¹⁹

By 1929, the poorhouse, like many others, continued much underused and in poor condition. That year, the new Local Government Act

transferred responsibility for poorhouses to County Councils and Inverness County closed the Skye Poorhouse presumably after a review of its underused facilities. In 1933-4, with Carnegie Foundation funding, it was converted to a school hostel to accommodate Skye children attending school in Portree and called the Margaret Carnegie Hostel. The ground floor was extended and a second storey was added as can be seen in the photograph above. It was used by Portree High School as a girls' hostel until April 2016. Planning permission to demolish the building and redevelop the site for a new Gaelic School was granted in 2015. The ground floor was granted in 2015. Planning permission to demolish the building and redevelop the site for a new Gaelic School was granted in 2015.

There is some evidence of a second poorhouse in Portree parish from 1883 with, in 1904, accommodation for over 20 adults and children.²² The location is unknown but it would be highly unusual to find this size of poorhouse close to the official poorhouse in Portree. In 1912, there was also a corrugated iron hut near Skeabost which functioned as a poorhouse.²³ Few details of these facilities remain.
