Loan agreements with Historylinks Museum for Provost's Chain of Office, Robes and other related ceremonial items

BACKGROUND

On 8/10/2020 Phil Tomalin (Ward Manager) signed two separate 10-year loan agreements with Historylinks Museum on behalf of the Dornoch Common Good for the following items:

E0783 - Provost's Robes:

- 1 no. Red robe with tassels & ermine collar (2022 025 01 = Provost);
- 4 no. Black & Red robes; (2022_025_02 = Dean, _04 = Treasurer, _05 = Senior Bailie, 06 = Junior Bailie);
- 1 no. Black & Burgundy robe (2022 025 03 = Town Clerk);
- 2 no. Black bicorn hats (2022 025 07 & 08)
- 1 no. Various accoutrements (2022_025_09)

E0784 - Provost's Chain of Office:

- a) Solid Gold (18ct) Chain with 12 no. Shields, 1 no. Enamelled Crest & 1 no. Gold Figure (2022_027_001-014)
- b) Gold with green enamelled Shield with Dornoch coat of arms (2022 026 01)

Following correspondence instigated by the DACC Chair, an email from PT on 17/2/23 stated that:

'following an examination of Dornoch Burgh Council minutes from 19 February 1975, Highland Council has reviewed the ownership of the Provost Chain and Robes. I am writing to confirm that the Council accepts that the Chain and Robes do not belong to Highland Council but were gifted to Dornoch Area Community Council via an intermediate trust. Therefore, please cancel the loan agreement for the Chain and Robes between Highland Council and Dornoch Heritage Society/ Historylinks Museum. You will need make a new agreement with the office bearers of Dornoch Area Community Council, assuming they elect to keep the items in the Museum.'

PROPOSAL

DACC members agree to authorise their Chair (Patrick Murray) to enter into a similar loan agreement with Historylinks Museum for them to be custodians of the above noted articles for a period of 10 years.

n.b. such an agreement does NOT transfer ownership of the articles and does NOT preclude the items being removed from the Museum, either temporarily or permanently, upon written request from DACC.

Dornoch Burgh Ceremonial Regalia - Enamelled shield

An enamelled shield with the Dornoch Coat of Arms, part of the Dornoch Burgh Ceremonial Regalia. The shield is of gold with green enamel and held in a leather box.

Dornoch Burgh Ceremonial Regalia - Chain of Office

A solid gold chain of 12 shields, with a central front enamelled crest and at the central back position a gold figure, designed to be upright when the chain is worn. Two of the 12 shields, those either side of the enamelled crest, are blank with the remainder bearing inscriptions of those holding the Office of Provost with relevant dates. The chain is held in a leather box.

Dornoch Burgh Ceremonial Regalia - Central enamelled crest

The gold and enamelled crest at the front central position of the Provost's Chain of Office. There is a small loop at the bottom of the shield, presumably for a means of securing the position of the shield on the robe of office.

The shields to the right and left of the central enamelled crest are blank, the remainder being inscribed with Provosts' names and dates of Office.

Working anti-clockwise from the central enamelled crest, the first engraved shield bears the inscription 'James Grant MacDonald Provost 1846 - 1953' beneath which there is a second inscription 'Rev Wm MacLeod Provost 1853 - 1955'.

Dornoch Burgh Ceremonial Regalia – 2nd engraved shield of Chain of Office

Working anti-clockwise from the central enamelled crest, the second engraved shield bears the inscription 'James MacLachlan Provost 1904 - 1913' beneath which there is a second inscription 'Rev William G Moore Provost 1913 – 1919'.

Dornoch Burgh Ceremonial Regalia - 3rd engraved shield of Chain of Office

Working anti-clockwise from the central enamelled crest, the third engraved shield bears the inscription 'George Granville KG Provost 1833 - 1861' beneath which there is a second inscription 'George Granville William Duke & Earl of Sutherland Provost 1861 – 1888'.

Dornoch Burgh Ceremonial Regalia – 4th engraved shield of Chain of Office

Working anti-clockwise from the central enamelled crest, the fourth engraved shield bears the inscription 'William 22nd Earl of Sutherland Provost 1750 - 52 56 - 66' beneath which there is a third inscription 'Lt Gen James St Clair of St Clair Provost 1752 - 55'.

Working anti-clockwise from the central enamelled crest, the fifth engraved shield bears the inscription 'John 18th Earl of S 1625 - 1663.' beneath which there is a second inscription 'George 19th Earl of Suth 1663 - 1703'.

Working anti-clockwise from the central enamelled crest, the sixth engraved shield bears the inscription 'John 20th Earl of Sutherland Provost 1703 - 1729.' beneath which there is a second inscription 'William 21st Earl of Sutherland Provost 1729 - 1753'.

Dornoch Burgh Ceremonial Regalia - 7th engraved shield of Chain of Office

Working anti-clockwise from the central enamelled crest, the seventh engraved shield bears the inscription 'The Hon James Wemyss of Wemyss Provost 1766 - 1775.' beneath which there is a second inscription 'George Granville Duke of Sutherland Provost 1785 - 1833'.
