# **Chapter seventeen**

#### CONCLUSION

- 17.1 This final chapter of the ES provides a summary of the main potential impacts, mitigation and residual effects associated with the proposed development that have been identified through the preceding environmental and technical assessments. Consideration of environmental and technical issues has influenced the design and layout of the proposed development and consequently, it incorporates elements of 'inherent mitigation' which are effectively 'built into' the site layout. The inherent mitigation measures are further detailed within each individual ES Chapter, with Chapter 3 'Scheme Description' explaining the design evolution process.
- 17.2 Table 17.1 provides a summary on a subject by subject basis of the main identified impacts, additional mitigation measures designed to offset, reduce or avoid those impacts arising and an outline of the residual effects likely to arise after taking these measures into account. Where significant residual effects remain after the implementation of mitigation measures, these have been highlighted.
- 17.3 Mitigation measures have been identified in Table 17.1. These form a proposed schedule of mitigation for the proposed development. There are a number of generic mitigation measures proposed which will address more than one impact and across more than one ES Chapter. These include the production of a Construction Environmental Management Plan (CEMP), a Breeding Bird Protection Plan (BBPP), a Traffic Management Plan (TMP), a Construction Traffic Management Plan, and a Pollution Prevention and Response Plan. These documents will be prepared, and agreed, with The Highland Council and relevant regulators and consultees in advance of construction works commencing on the development site.
