**POLICE REPORT, MAY 2021**  
**BEAT AREA MW05 – ROSEWELL & DISTRICT**



From 26<sup>th</sup> February to 14<sup>th</sup> April 2021 in the beat area MW05 – Rosewell & District – There were 8 crimes recorded, with 3 solved to date for the Rosewell area.

**Incidents of Note**

-About 9pm on Saturday the 1<sup>st</sup> of May police stopped a car on Gorton Road and several defects were identified. A prohibition notice was issued to the 20 year old man driving the car, meaning that the car could not be driven until the defects were addressed and an MOT carried out.

-About 8am on Tuesday the 4<sup>th</sup> of May a small silver vehicle (not further described) collided with a silver Nissan Quashai on the roundabout at Rosewell on the A6094 and failed to stop. No parties were injured during this incident and police enquiries are ongoing.

-About 6pm on Monday the 17<sup>th</sup> of May a black Vauxhall Zafira was reported to be driving erratically on the A6094 passing Rosewell. Police made attempts to trace the vehicle and driver, but were unable to do so.

-Between 6pm and 9pm on Monday the 17<sup>th</sup> of May a blue Apollo Phase men's mountain bike was stolen from the front garden of a property at Cochrina Place. Police enquiries are ongoing.

-About 5pm on Thursday the 20<sup>th</sup> of May a 49 year old man reported having been assaulted by a 54 year old man during a dispute over property whilst within a property at Shiel Hall Gardens. Enquiries were made in to the incident. No further action was taken against the 54 years old and the 49 years old has been reported to the Procurator Fiscal.

-About 3pm on Friday the 21<sup>st</sup> and 23.30pm on Monday the 24<sup>th</sup> of May several windows were damaged and entry gained to a property at Carnethie Street, nothing was stolen from within. Police enquiries have concluded and no suspect(s) identified.

-About 5pm on Saturday the 29<sup>th</sup> of May a group of youths were reported to be smashing bottles at Carnethie Street, police searched the area, but the youths had left the area.

**Community Police information**

Police are continuing to receive reports of parking issues and potential covid-19 regulation breaches throughout Midlothian and are maintaining patrols in this area.

In addition to the clearway at Flotterstone, there is now a clearway in operation at Penicuik Estate, Penicuik. This covers a section of the A766 Carlops Road outside Penicuik Estate and part of the unclassified road known as Lowrie's Den opposite Penicuik Estate. Signs are in place to show the clearway area.

Any vehicle found parked within this area can be uplifted and the driver can be issued with a fixed penalty notice.

On 13<sup>th</sup> March 2021, Midlothian Police launched their Rural Crime Campaign. This campaign will run until 2<sup>nd</sup> May 2021. This aims to target Livestock Offences, Wildlife Crime, Acquisitive Crime and more. Police will be conducting mobile patrols at weekends in rural areas including The Pentland Hills and Penicuik Estate. If you see anything suspicious or crimes ongoing please contact 101 or 999 immediately.

Rogue traders and bogus callers operate throughout the year but become more frequent after spring. Current restrictions mean more people are at home when they would usually be at work, and as a result they may encounter more doorstep callers who know householders will most likely be in when they ring the doorbell.

Police Scotland is asking the public to follow its advice if they receive an unexpected, and unknown, caller at the door:

- Always ask for identification;
- Never feel pressured into making an on the spot decision;
- Never hand over money on the doorstep.
