1	POLICE REPORT	
1.1	PC Alan Forbes reported the Rosewell Crime statistics for November 2019 which can be viewed on RDCC website CRIME REPORTS page. There were 9 crimes recorded with 5 solved. During this period there were 50 calls to Police Scotland. The meeting was reminded of the numbers to contact Police Scotland when telephoning, also Your View Counts – details are on the report. 6.1	Brown Bins - Midlothian Council has approved plans to continue the chargeable kerbside garden waste collections. (Brown bin). At the full council meeting on Tuesday, it was confirmed the scheme had generated a net income for the council of £591,178 in 2019. Councillors agreed the service should be offered to residents again in 2020, with the charge remaining static at £35 per bin.	MC/ Residents

10.1	Moray Simon (Resident) came forward with a question for the hall and asked if those who	RDCC/
	were present at the last meeting (7th October 2019) recalled the discussions that took place	Residents
	with him and the development trust Manager and board member. Moray said "I spoke up	
	because I felt they were bullying Ann and demeaning our Community Council". Does anyone	
	recall me using any derogatory or demeaning words language towards them? A number of	
	residents confirmed nothing derogatory had been said by Moray.	
	Moray then explained that he had been a member of the Development Trust since it started	
	up and that in April 2019 (just before their AGM) found out he was no longer a member, but	
	doesn't know the reason why and hasn't got to the bottom of it. Moray then said he had	
	recently re-applied for membership to RDT which had been refused, with the reason given for	
	refusal was that he had made derogatory remarks towards the Manager and a board member of RDT at the RDCC public meeting in October.	
	An ex board member of RDT said that in order to comply with GDPR, emails were sent out by	
	RDT asking people to reply if they wanted to remain on the mailing list, but didn't recall it	
	saying anything about membership and people who didn't reply appear to taken off the	
	membership. A number of people said they had not been contacted.	
	Moray told the meeting he had received the email and replied at the time. The Secretary also	
	received the email and responded to it, however was told she was never a member, despite	
	the email stating – you are receiving this email 'because you are a member'	
	A discussion then took place whereby a number of residents stated they were unaware of	
	what had happened regarding memberships and assumed they were still members and many	
	thought it was a 'lifetime membership'	
	RDCC had questioned RDT about the timing of the issue with memberships immediately	
	before their AGM because being told to re-apply for membership on the day of the AGM or	
	after was wholly unsatisfactory due to members having lost their voting rights, especially	
	when they were proposing to make changes to their Articles of Association. In particular	
	changes being made to exclude Appointed members of the Community Council to the board of RDT.	
	A further discussion took place regarding RDT's articles of association and particularly about	
	appointment of board members and it was believed by Moray that RDT were keeping two	
	appointed members but had removed Community Council member.	
	RDCC's ex board member said she had resigned for various reasons, but stated mainly she	
	was fed hearing the news of what was happening at RDT from residents at Community	
	Council meetings.	

10.2	Another resident confirmed she had been told she was no longer a member prior to the AGM, however had been reinstated before the AGM, which certainly was not the case for others! It was apparent by the number of comments made that residents were unhappy by the actions of RDT regarding their memberships. Moray said that it seems RDT don't like anyone who makes comment or criticises them and they are willing to concoct fake allegation to get their way. This matter is not closed and is being taken further. A resident reported phoning MC regarding state of cemeteries and could more bins be placed	MC/
	within however one brown bin had been placed and was overflowing. She also stated her disappointment with the overall state of neglect and was given an apology and told residents would need to do more. However, she questioned the money being paid to the council and would there be if refunds made if people were doing it themselves.	Residents
