1.	APOLOGIES FOR ABSENCE – Ms Mackenzie, Mr Macrae, Mr Holdsworth. Mr Munro gave thanks to Mr Macdonald, and an appreciation was given for all the work he had done, and wished him well for the future. A welcome was given to Mr Piper as a returning member.
2.	POLICE REPORT
2.1	Mr Munro read out an email from Inspector Johnston re the crime statistics for the month, which were – 1 person charged for domestic non-physical, 1 person charged for theft by shoplifting, 1 person charged for road traffic offences, and 9 persons charged for speeding offences. Patrols ongoing around Scotsburn Court, and the Rose Garden. Calls to Morangie House have been minimal this month. It was sadly noted of a death of a youth in the Mansfield Estate. Mrs Robertson reported about the knitted trauma teddy’s, which are given to children to help with situations.

3.1	The Minutes of the meeting held on 27 August 2018 were approved by Mrs Mackenzie, and seconded by Mr Amos.

4.1	Ref Asda Path – it was noted that the works to fix the drainage had been completed. The situation is going to be monitored.
4.2	Ref WW1 ending – Mr McAllister asked to write the wording for the brass plaque which will be placed in the triangle garden, once the wording is approved. The CC approved the wording.

5.1	It was noted that there were no Academy School reps this year attending the CC meeting. After discussion, it was agreed that Mr Macdonald would contact the school again on this matter.

<p>6.1</p> <p>6.2</p>	<p>Mrs Roberson's report. Mrs Robertson reported that as part of the WW1 endings there is going to be a rose bush planted in the Rose Garden. There is also going to be a People's Parade. There is also a Poppy Parade. The pupils in the Schools are designing the Poppies. Craighill Primary School have now got new toilets, and a partition between classrooms. Work still to be done on ceilings. P1 is nearing at full capacity. Part of the Rose Gardens railings have been taken away due to health and safety issues. The Community Payback group are going to be undertaking painting and other items. Car parking charges – the Ross-shire area is against them. No detriment this year if do not make the target. There is a new Chief Executive – Donna Manson. A new Director of Care & Learning will be appointed soon.</p> <p>Mr Louden's report. Mr Louden indicated that CC members can arrange to meet before the Remembrance Service on 11th November. There was a meeting on WW1 endings, and it was agreed that there would be commemoration and not celebration. Mr Louden to provide a reprise. Car parking charges – Parking Enforcement Officers will be working throughout the Highland, and will come to Tain once the yellow lines are completed. Toilets – counter in Tain ones, with a low footfall. Ward Forum – John Bruce from Fisheries Protection is going to speak about boat licenses. Cunarder Lane has been tidied up by the Community Payback group. A report on the 3-18 Campus will be going to Committee. HC have yet to agree site selection.
