INSHAW addressed the council to explain that the back of the building is the front from his perspective, living in Cwn Mabws and that he and other residents of the valley are concerned about the potential impact of the proposed changes on the wellbeing of residents of the valley, the tranquility of the valley which is appreciated by both residents and tourists, light pollution and the unique bio-diversity of the valley.</i> <i>Mr. INSHAW continued that he considered it to be important to the democratic process that residents can make their concerns known to the council, this in the context of the deadline for representations for this particular proposal having passed before the community Council meeting.</i> <i>G. EVANS suggested that though the deadline had passed it may still be possible to submit a representation.</i> <i>T. VENABLES addressed the council to express his concerns, highlighting the increased noise experienced during the recent world cup and how the proposed extension could have a similar material impact on local residents.</i> <i>G. JONES proposed a motion that the council would not object to the planning permission.</i> <i>The motion was passed 6 to 0.</i> <i>G.
