Thank you for the CCC letter of 20.03.23 from Mr Rhodri Llwyd, the content of which is disappointing.

The answers to your questions have all been provided within previous correspondence.

However, we have once again provided the requested responses to these questions below.

Q1: Could the Community Council confirm that the 'LICC grant application' to which you refer is the one submitted by Mr. Tudor Jones to Ceredigion County Council on 3 February 2022?

A1: Confirmed.

Q2: Confirm that LICC holds written confirmation that all four landowners have agreed in principle to provide land for the proposed route.

A2: Confirmed.

Q3: Provide information/evidence to support claims that CCC has not been providing 'active and timely responses' to communication.

A3: The information sheet previously provided, catalogues the difficulties in eliciting a response from CCC. Our elected councillor has been attempting to get answers since May of last year without any success, other than the one response, re. enquiry reference 429598 (requested on 18/7/22), which was received by e-mail on 24/2/23.

Therefore, on the basis that answers have previously been provided to all your questions, we look forward to your early response to the outstanding questions raised & summarised in our last letter.
