MINUTES OF THE MEETING HELD ON
Monday 13th May 2019 AT 5.00PM THE VILLAGE HALL, GREAT THIRKLEBY

PRESENT : Councillors Richard Atkinson (Chair) (Honorary Clerk and Financial Officer), Alison Turner, Jacqueline Smith.

There were no members of the public present.

Cllr Richard Atkinson volunteered to chair this meeting.

19/12 APOLOGIES FOR ABSENCE and declarations of interest.

Cllr Beth Barber-Atkinson sent apologies for absence. There were no declarations of interest.

All Parish Councillors signed the Acceptance of Office forms.

19/13 TO CONFIRM THE MINUTES OF THE MEETING HELD ON 25th FEBRUARY 2019

The minutes had been circulated prior to the meeting. The minutes were unanimously confirmed as a true and correct record and signed by the chairman.

19/14 PUBLIC FORUM.

District Councillor Jill Mortimer introduced herself and was welcomed to the meeting.

19/15 PLANNING APPLICATIONS FOR CONSIDERATION, HDC decisions.

1. Change of use and various demolition, rebuilding of hangers, clubhouse etc. & increased flight numbers. To include rolling up of fourteen breaches of planning control. Bagby Airfield. **16/02240/FUL HDC have APPROVED this application however the Secretary of State has "called in the decision" for review.**
2. Planning Breach, Garage, The Bungalow, Great Thirkleby **14/01872/FUL** The original permission had been granted with the condition that red clay bricks would make up the walls, however grey concrete blocks have been used. *Councillors will lobby HDC Planning managers to rectify this breach. Ongoing - awaiting reply from HDC and a F.O.I request on this planning issue is now overdue.*
3. Replace Existing Wooden Store with Brick/Block Building, The Bungalow, Great Thirkleby, **19/00246/FUL GRANTED by HDC.**
Councillors object to this application due to concerns raised by neighbours and the unresolved breach of conditions on the same site. also - awaiting reply from HDC for a F.O.I request on this planning issue.
4. Outline Application for Detached Two Storey Dwelling, Manor Farm, Little Thirkleby, **19/00084/OUT REFUSED by HDC.**
5. Proposed construction of an agricultural dwelling, OS Field 8400 Vicar Hill Lane Little Thirkleby, **19/00057/FUL Awaiting Decision from HDC.**

19/19 FINANCIAL MATTERS.

Cllr Atkinson presented the current financial position:

1. Income since last meeting: £1000 being half of the annual precept.
2. Payments since last meeting: £15 hall hire, £45 pop-up-pub, £255.60 defibrillator repairs, £300 TV donation to Parish Hall.
3. The bank balance at 30th April 2019 was £5624.45.
4. Bills due for payment: £15 hall hire, £45 pop-up-pub, £125 YLCA, £182.80 insurance, £178 March / April grass cutting.
5. The budget/financial forecast for 2019/20 was studied and approved.


19/20 REPORTS FROM COUNCILLORS.

1. Cllr Smith reported that the salt/grit bin on the village green was damaged and often being hit by vehicles turning. A new site was proposed and costs sort for next meeting.
2. Cllr Smith reported that a stile on a footpath near Thirkleby Beck was in need of repair. Cllr Atkinson will report it to Highways.
3. **UPDATE ON FOOTPATH REPAIRS AT LITTLE THIRKLEBY**
Councillors considered that the work carried out by North Yorkshire County Council contractors was not up to standard. Days after the path had been laid several baggy patches had appeared. NYCC had already passed the work. The £2000 grant has now been lost however NYCC have agreed to void the invoice for the work. TPC could not warrant paying public money towards a substandard job. Cllr Turner will contact NY Water and HDC Environmental Services again re drainage.
