18/56 PLANNING APPLICATIONS FOR CONSIDERATION, HDC decisions.

1. Change of use and various demolition, rebuilding of hangers, clubhouse etc. & increased flight numbers. To include rolling up of fourteen breaches of planning control. Bagby Airfield. **16/02240/FUL Awaiting decision.**

2. Planning Breach, Garage, The Bungalow, Great Thirkleby **14/01872/FUL**

The original permission had been granted with the condition that red clay bricks would make up the walls, however grey concrete blocks have been used. Councillors will lobby HDC Planning managers to rectify this breach. Cllr Turner to take this up with Helen Kemp of HDC Planning. **Ongoing.**

3. Change of use of agricultural land, demotion, of agricultural building, construction of one holiday cottage, Old Oak Cottages, Little Thirkleby. **18/01916/FUL Granted.**

4. Pruning the Weeping Lime Tree Thirkleby Village Green **18/02257/TPO Awaiting decision.**



18/57 CLERK'S REPORT.

County Councillor Caroline Patmore offered a grant of £2000. The cost of repairs will be split three ways, between Highways, the grant and the parish council. TPC share will be £677.50 plus vat. This spend was unanimously agreed.

18/59 FINANCIAL MATTERS.

1. Income since last meeting: £1000 half of the precept.
2. Payments since last meeting: £15 hall hire, £45 pop-up-pub. £378 grass cutting.
3. The bank balance at 31st October 2018 was £5588.05.
4. Bills due for payment: £15 hall hire, £45 pop-up-pub, £288 July, August, Sept. grass cutting.
5. The budget/financial forecast was studied and approved.
6. The Precept for 2019/2020 was agreed to remain at £2000.


18/60 REPORTS FROM COUNCILLORS.
