18/22 PLANNING APPLICATIONS FOR CONSIDERATION, HDC decisions.

1. Change of use and various demolition, rebuilding of hangers, clubhouse etc. & increased flight numbers. Bagby Airfield. **16/02240/FUL Awaiting decision.**
2. Planning Breach, Garage, The Bungalow, Great Thirkleby **14/01872/FUL**

The original permission had been granted with the condition that red clay bricks would make up the walls, however grey concrete blocks have been used. Councillors will lobby HDC Planning managers to rectify this breach.

4. Bills due for payment: £15 hall hire, £157 grass cutting, £183.86 Annual Insurance.

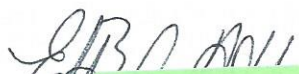
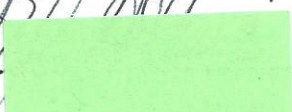
18/29 REPORT FROM COUNTY & DISTRICT Cllr PATMORE
