## 19/04 PLANNING APPLICATIONS FOR CONSIDERATION, HDC decisions.

- Change of use and various demolition, rebuilding of hangers, clubhouse etc.& increased flight numbers. To include rolling up of fourteen breaches of planning control. Bagby Airfield.16/02240/FUL Awaiting decision.
- 2. Planning Breach, Garage, The Bungalow, Great Thirkleby 14/01872/FUL

The original permission had been granted with the condition that red clay bricks would make up the walls, however grey concrete blocks have been used. Coucillors will lobby HDC Planning managers to rectify this breach. **Ongoing.** 

- 3. Pruning the Weeping Lime Tree Thirkleby Village Green 18/02257/TPO Granted.
- Replace Existing Wooden Store with Brick/Block Building, The Bungalow, Great Thirkleby, 19/00246/FUL New Application.
   Councillors object to this application due to concerns raised by neighbours and the unresolved breach of conditions on the same site.
- Outline Application for Detached Two Storey Dwelling, Manor Farm, Little Thirkleby, 19/00084/OUT New Application. No Objectons, infill between houses within village boundary.
- 6. Proposed construction of an agricultural dwelling, OS Field 8400 Vicar Hill Lane Little Thirkleby, 19/00057/FUL Councillors object as not in keeping with village and on green field site.

#### 19/08 UPDATE ON FOOTPATH REPAIRS AT LITTLE THIRKLEBY

Councillors considered that the work carried out by North Yorkshire County Council contractors was not up to standard. Days after the path had been laid several baggy patches had appeared. NYCC had already passed the work. The £2000 grant may be lost if not resolved by the financial year end however TPC could not warrant paying public money towards a substandard job. TPC will withhold payment and contact NY Water and HDC Environmental Services re drainage.

### 19/09 RESOLVE TO PAY £255.60 FOR REPLACEMENT BATTERY FOR DEFIBRILLATOR
