### 16/24 ELECTION OF OFFICERS

- Cllr Richard Linton was unanimously elected as Chairman and his acceptance of office was signed.
- Cllr Richard Atkinson was unanimously elected as Honorary Clerk and Responsible Financial Officer.

Clir Alison Turner was unable to attend. There were no declarations of interest.

## 16/27 TO CONFIRM THE MINUTES OF THE MEETING HELD ON 21st April 2016

These were confirmed unanimously as a true and correct record and signed by the chairman.

### 16/28 THE PURCHASE OF PICNIC TABLES AND BENCHES

The outcome of a Residents Meeting of 12<sup>th</sup> May 2016 was that there were no objections or alternative uses for the £800 Village Compensation Fund. Comparable prices had been sort and it was unanimously agreed that three picnic benches and two park benches be purchased locally to replace existing seating on the village green that were now beyond repair.

#### 16/29 FINANCIAL MATTERS. Cllr Richard Atkinson.

During the yearend checks Cllr Atkinson had noticed a typing error in the 11<sup>th</sup> February Minutes; the bank balance had been minuted as £3408.81 where as in fact it should have been £3048.81.

Cllr Atkinson presented the current financial position:

- 1. Income since last meeting: £1375 being 50% of the annual precept.
- 2. Payments since last meeting: £212.86, payment 3 of 4 election fees from previous years. £10 bank charge for cancelled cheque no.278.
- 3. The bank statement of 29<sup>th</sup> April 2016 was £4200.95 although cheque 270 YLCA £117.00, cheque 281 Village Hall £30 & cheque 282 Village Hall £15, had still to be banked. This would bring the current bank balance to £4038.95. This balance includes £800 still held by the Parish Council which is ring fenced for community benefit (new benches).
- Annual Insurance, £199.73 due 1<sup>st</sup> June; it was unanimously agreed to renew the insurance.
- The accounts for the year ending 31 March 2016 were unanimously approved and the chairman signed the balance sheet.

- 6. The chairman read through the Annual Governance Statement and all agreed the responses.
- The Annual Accounting Statement was unanimously approved.

The dates will be confirmed depending on the availability of the Village Hall.
