Governance

Hurworth Village Hall was established as a charity by a Trust Deed dated 17th August 1966. The hall was originally a Temperance Hall together with Onward House. The Temperance Hall was built in the late 1860's.

The village hall management committee is responsible for keeping the building in good state of repair.

Appointment of Trustees

The Trust Deed governs the appointment of trustees and the management of the charity.

The Management Committee consists of twelve members:

- Six elected Members
- Two Representative Member
- Four Co-opted Members.

Meetings

The Management Committee has met on three occasions over the last year and all meetings have been well attended, with 80% attendance.

The meetings have also been attended by Lorraine Tostevin, Darlington Borough Council Councillor and her contribution, support and encouragement has been gratefully received.

Policies and Procedures

To guide the Management Committee in exercising its duty of care to members, employees and users of the hall, the following eight policy statements remain in place:

- Trustees Policy and Procedures
- Hall Booking Policy and Procedures
- Health and Safety Policy and Procedures
- Finance Policy and Procedures
- Child Protection and Vulnerable Adult Policy
- Equal Opportunities Policy
- Complaints Policy and Procedure.
- Privacy Policy.

The policies have continued to be implemented to ensure that the running of the Hall remains friendly and flexible and that the Hall is not overburdened and over governed by unnecessary bureaucracy. The policies are there for the guidance of users as well as for the Trustees. These are periodically reviewed.

During the Covid 19 pandemic, the guidance from Action with Communities in Rural England (ACRE) and Public Health England (PHE) have informed amendments to the policies on the Hire of Hurworth Village Hall and the running of Hurworth Village Hall to ensure this follows national guidance. All restrictions for the Covid 19 pandemic were lifted in March 2022.

Hiring Agreement

Use of the Hall is subject to a Hiring Agreement which must be signed by the hirer when booking. The hiring agreement sets out the conditions of hire and identifies the respective responsibilities of each party to the agreement.

This was updated in June 2020 to ensure adherence to Covid -19 guidelines during the pandemic.

Licences

The Hall has:

- A Premises Licence (not including alcohol) and has The Music License (combining PRS and PPL licenses) for live and recorded music. The Music License represents an annual charge to the Hall, at £250.68 for the current year.
- A Motion Picture Licensing Umbrella License has been gained which has enabled films to be screened as long as a charge is not made. The annual fee for this was £132.00.
- TV License to enable live stream via the cinema system. Cost this period: £159.00.

No Temporary Events Notice's have been applied for during this period.

Risk Management

Insurance

The Management Committee recognises that it is under a legal obligation to protect the building, its users and employees through adequate and appropriate insurance.

The Hall has insurance with Allied Westminster (Insurance Services Ltd). Fee: £889.80.

The village hall is insured with respect to property damage (buildings insurance). It is insured with the same company with respect to contents, public liability, employers' liability and legal assistance.

The Hall building was last valued in August 2019 to ensure that the level of insurance was appropriate. At this time it was valued at £371k.

Allied Westminster have also been a source of advice with the advent of the Covid 19 pandemic ensuring that insurance remains valid during periods of closure.

Building Issues

The Village Hall is an old building, which is well maintained through the caretaker, Mr David Crisp with the support of Jilly Lawrence. The Trustees are aware of the need for ongoing maintenance and repair/ replacement to maintain modern facilities which are both in good working order and have consideration for the environment.

Within this financial year 2021 - 2022 the following have been completed:

- General maintenance / decoration.
- Boiler servicing.
- Roof repairs.

The planned further refurbishment includes:

- Replacement of the arched windows to improve heat efficiency from the legacy left by John Gent.
- Replacement radiators to the back room.
- Replacement floor to the back room.

To ensure the safety of users the following has been undertaken:

- Gas appliances and portable electrical appliances are tested by qualified personnel annually.
- The mains electrical installation is checked by a qualified engineer every 5 years.
- A Fire Safety Risk Assessment is updated annually by the Committee as required by law.
- Firefighting appliances are inspected annually under contract with the supplier, Chubb.
- Volunteers from the Committee carry out other regular maintenance checks.
- Darlington Borough Council Environmental Health Officers undertake inspection of the kitchen. The kitchen has a five star rating.

The Trustees would like to thank all those responsible for their considerable work and effort in keeping the Hall in such good and attractive condition.

Objectives of the Charity

The primary object of the charity is defined below:

The Object of the Foundation shall be the provision and maintenance of the Hall for the use of the inhabitants of the Parish of Hurworth and the neighbourhood (in this Scheme called the 'area of benefit') without distinction of sex or political, religious or other opinions, and in particular for the use of meetings, lectures and classes and for other forms of education, recreation and leisure-time occupation, with the objectives of improving the conditions of life for the said inhabitants'.

Principal Activities in pursuit of Objectives

With the government restrictions due to the Covid 19 pandemic, the Hall has operated within the government guidelines to March 2022 following the re-opening of community venues on the 17th May 2021.

Summary of Hall activities:

- The Hall is used every weekday with activities ranging from Indoor Bowls, Art, Pilates, Yoga, Flower Club, Latin Dance, Line Dance, Jolly Fit, Craft classes and Patchwork and Quilting.
- Film afternoons on the first Sunday of each month.
- Private functions including birthday parties and commercial events.
- The Hall is also available for local Charity events and meetings. For instance the McMillan coffee mornings. For charitable events and meetings there is no charge for the Hall's rental.

Additional fund raising events have also been held. These include:

- Quiz Nights September 2021, December 2021, March 2022, June 2022
- Murder Mystery Evening 30th October 2021
- Hot Club Du Nord 12th December 2021
- Polar Express 18th December 2021
- Queens Platinum Jubilee Celebrations 5th June 2022
- Rhapsody, Hurworth Choir 25th June 2022
- Armed Forces Day on the Village Green 26th June 2022
- Music in the Park 16th July 2022

The Hall's use has recovered following the Government's lockdown restrictions and the periods of closure and we are grateful for all those who have supported the Hall, booked private function and attended either regular classes or events. In summary:

- The footfall in this period has been approximately 5,993 people. This is higher than the pre Covid footfall for the year 2018 2019 of 5,700 people.
- The Hall utilisation when Hall opening has not been affected by the Covid 19 pandemic restrictions is approximately 72% which is an increase on the previous usage, when the Hall has been fully operating, of 66%.

The Hall, and its events, continues to be promoted in a number of ways including its own website, its own page on Facebook, Mailing list via Mailchimp, Parish magazines and other local media. A leaflet drop was completed to all new houses on the Bellway and Miller estates in August 2021 to promote awareness of the Hall and its activities.

Overall the use of the Hall and associated payments along with fund raising activities arranged by The Trustees covers the running costs of the Hall. There has been this year a surplus of £7,660.24.

Everyone involved in the organisation and running of the events is thanked for their time and hard work.

The Hall is grateful for the support of The Parish Council and the close collaborative work with the Grange for events.

Funding Strategy

It is the strategy of the Trustees to manage the revenue budget on a self-financing basis together with regular fund raising events and the application for grants when available.

Within this reporting period there have been the following grant for capital investment:

• Hurworth Parish Council (New Chairs)

£1,200.00

The Hall has been awarded the following grants / allowance in respect of Covid 19 from Darlington Borough Council:

• Omicron Hospitality and Leisure Grant 02/02/22

£2,667.00

Hurworth Parish Council has also financially supported both the Armed Forces Day, the Music Event and the Queen's Platinum Jubilee Celebrations.

Users of the Hall contribute to the financing of the Hall. The hire rate for the rooms in the Hall for both regular users and one off user's has remained the same in this period. This is considered to be competitive with similar venues.

Rent is paid by a neighbour for the garden to the rear of the building. This is paid in full and following review it was agreed that this remains at the current rate.

The Hall is also grateful for donations received.

The registration with HMRC for Gift Aid has been made but no claims were made during this period.

Volunteers' Effort

Management costs are kept to a minimum through the use of volunteers and friends in the organising and setting up / clearing away and running of events. In addition, Trustees attend meetings up to four times a year and together give approximately 1400 hours per annum in maintaining the Hall and organising / running fund raising events.

Accountancy and financial auditing services have also been given to the Hall on a voluntary basis and the Hall is very grateful for this continued support.

All volunteers are fully appreciated and the Trustees are gratefully thanked for their support, time and effort.

2021 - 2022 Achievements

The Trustees work hard to make the hall attractive to potential users and measure their success by the range of users, the variety of events organised and the hall occupancy.

During this period the Hall has:

- Achieved a compliment of 75% of Trustees.
- Maintained the financial viability of the Hall for the use by the community in line with the objectives of the charity.
- Successfully responded to Covid 19 and enabled the resumption of Hall activities when possible in line with government guidelines.
- Successfully applied for the additional Covid 19 restriction grant from Darlington Borough Council.
- Ensured funding for the continued improvement of the Hall.
- Completed essential maintenance and improvements to the Hall during 2021/2022.
- Re-instated the varied programme of classes post Covid19 restrictions.
- Maintained links with other community providers and the Parish Council to ensure collaborative working and the co-ordinated provision of events across Hurworth.
- Been instrumental in organising very enjoyable Music Event and the outstanding Queens Platinum Jubilee Celebrations. Both these events were very well attended by the wider Hurworth community,

Reserves

The village hall keeps a Community Account as a contingency fund and this has £4,322.37 balance. This cash is available for unforeseen expenditure in relation to building maintenance or urgent furniture or equipment replacement. This fund has not been accessed during the reporting period.

Future Plans

For the coming year the Trustees will continue to work towards increasing the usage of the Hall and maintaining it as a warm and welcoming environment that people wish to attend. For the coming year the following is planned:

- Trustees To establish a full complement of Trustees to the committee.
- Building refurbishment To further refurbish the Hall to maintain the Hall as a
 warm and welcoming environment. This includes the installation of new arched
 windows to the front and the refurbishment of the back room floor.
- Hall presentation To maintain funding for the cleaner (who commenced just after this reporting period).
- Funding To optimise the use of grants as available, review hall rental charges in response to rising costs and ensure that services paid for are reasonable.
- Reserves In view of the rising cost of repairs/ trades the Trustees plan to increase the reserve amount available by at least 25%.
- Safety / risk management There will be continuous review of current guidance and legislation to ensure the safety of all.
- Promoting Hall use Continued development of regular classes / groups and a varied programme of one-off activities to ensure the continued financial viability of the Hall.
- Collaborative working Collaboration with other activity and event providers in the local area to ensure a co-ordinated approach to Hurworth wide events in the village to facilitate income maximisation for all.
- TVVHN Utilisation of the programme of information and events arranged through TVVHN.
