Swimming Pool

It was asked about the cluster of gas leaks at the swimming pool. The council were made aware of these, it was agreed a report will be given at our next meeting.

Xmas Lights

Kevin reported that the group will be called Prestonpans Events. We had a Family Fun Day which raised £525.35. We are holding a Race Night at The Labour Club 5th October aiming to raise £1000. We cut the lights back to 36 last year. We were told that to repair the old light repairs this would be £6600. The cost for ELC to erect light on per lamp post is £90. We are planning more events. The switch on this year will be Sunday 1st December and are in early talks with the Infant School for the venue. Work on the Red School is due to start soon where we will have our own repair room.
