Matters Arising

Pipeline

We welcomed Douglas Proudfoot from ELC. He explained the work and role of The Cockenzie Forum.

He explained that in the 1963 agreement, (which was set up on the construction of The Power Station) the pipeline was not included in this.

We raised our concerns of:

Current condition.

Exposed area between Musselburgh Lagoons sea wall to where houses start at Prestonpans which are not encased in concrete.

Exposed areas which are not encased in concrete from behind Fowlers to Power station site in soil and shingle.

Health and safety and environmental.

No maintenance plan

Identify who is and will be responsible for maintenance.

A recent site visit was carried out before this meeting behind Auldhalmer House where it was identified that in areas where the pipeline was encased in concrete some areas needed attention. Exposed areas on the direct shoreline were not included on this site visit.

It was agreed that we would formally write to Douglas raising our concerns, to take this matter forward, and clarify ownership of areas of shoreline concerned.
