The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2021-22 was £8.41 per elector.

I report in respect of my audit of the accounts under section 13 of the Act, whether any matters that come to my attention give cause for concern that relevant legislation and regulatory requirements have not been met. My audit has been conducted in accordance with guidance issued by the Auditor General for Wales.

Auditor General's report

Audit opinion – Unqualified

On the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters arising and recommendations

Standing orders and financial regulations

We note that the Council is in process of reviewing its standing orders and financial regulations to bring them up to date with the Council's established practices, particularly with the use of online banking.

Our audit identified payments related to grass cutting that exceed the threshold set by the Council's financial regulations as requiring tenders. It is not clear whether or not the Council obtained tenders for this contract.

We recommend that the Council prioritises the review of its standing orders and financial regulations including thresholds for contracts and banking arrangements to ensure that the documents are relevant and up to date.

We recommend that the Council reviews all contracts entered into and establishes the full value of the contracts and whether it now needs to put the contracts out to competition in line with the updated regulations.

Clerk's salary

We noted from our inspection of the Council's payments that the Clerk is paid quarterly. The contract of employment states that payment is to be made monthly. We recommend that the terms of payment are clarified.
