4.1 Adeilad Cymunedol –Daeth Helen o Cadwyn Clwyd i'r cyfarfod. Mae Cadwyn Clwyd yn cadw £10,000 i un ochr ar gyfer y darn gwaith nesaf yn y prosiect, mae Sam wedi cael £3,000 'match funding' gan Brenig Wind a fydd hwnnw yn mynd yn syth i Cadwyn Clwyd a byddan nhw yn rhoi y £7,000 arall i wneud £10,000 i gyd. Bydd Helen nawr yn helpu ni i greu 'gwahoddiad i ddyfynnu' gan osod allan popeth rydym ei angen allan o'r ddogfen, h.y opsiynau am adeilad newydd ac am adnewyddu y Church House, a costau am y ddau adeilad. Nid yw'n bosib cael grant ar gyfer prynu tir, felly mae angen cysidro hyn a bydd rhaid codi arian neu cael benthyciad i brynu tir. 4.2 Bydeang – dim diweddariad 4.4 Defib yn y Waen – Mae'r cyfnod ymgynghori wedi cychwyn pythefnos yn ol.
