Councillor Parker has confirmed that a bin would not be suitable on the Quarry footpath, however signage to be agreed and supplied to recommend the county code of conduct with the stick and flick approach. The sign and costings will be discussed at the next meeting.

- 21/2L Councillor Reports
Councillor Parker advised that there has been no update to the Cross Lane Group from Axbridge Town Council. They plan to discuss how to move the project forward. The group will also discuss weight restrictions on Cross Lane and will report back at the next meeting. Councillor Parker observed that the path from Cross to Weare has been cleaned and cleared and looks hugely improved.
- Councillor McCarthy provided a report prior to the meeting, Councillor Filmer will follow up with Highways on the road surface work on Cross Lane. Councillor Filmer will ask Skansa for the material for the potholes on the Webbington Road.
- Councillor Brownlow sent her report prior to the meeting. After a lengthy discussion it was agreed to advise residents who have concerns regarding the pheasant shooting to contact the Police who have the authority to liaise and investigate matters.
