Mr Chris Vinnicombe spoke regarding PA20/08522 to update Councillors concerning proposed changes to his planning application. His agent, Ben Wood, stated that the Planning Officer suggested that the applicant take the Council's comments into consideration and plans have been amended and sought to circulate some additional information.
