NB Where the terms "Leader" or "Leaders" are used, this also includes where appropriate any QuadKids personnel, UKA Qualified Coaches, UKA Qualified Officials, Teachers, Volunteers or Young Sports Leaders who are supervising or leading/helping with a QuadKids, Super8 or Super6 competition activity or event. It is the responsibility of the Leaders to constantly monitor the activity for any safety issues and to take appropriate action to ensure that participants'/athletes' and/or their own safety is not put at risk. If in doubt they should consult the Competition and /or Event Manager.

High jump, shot, long jump and javelin events in Super8 or Super6 competitions **must** be lead by an adult eg QuadKids personnel, suitably experienced teacher, UK Athletics qualified Official, UK Athletics qualified Coach. **Under no circumstances should these events be lead by a Young Sports Leader.** 

Anyone acting in a supervisory capacity is expected to set a good example to the participants. This is particularly important where QuadKids Primary School events are being lead by Young Sports Leaders and includes walking back with Vortex Howlers and not throwing them back to the start line ie throwing them towards the athletes.

\*The reality of running QuadKids, Super8 or Super6 competitions, in common with other athletics competitions, is that they require lots of people to manage the events ie shot, 100m etc. This means that Young Sports Leaders and other volunteers/Leaders are likely to be asked to assist in running the events. Where possible, each event eg shot will include a Leader who either holds a valid CRB check or who holds the new Disclosure and Barring Service Police Records Check. In practice this may not be always be possible but the risk is considered to be low on the grounds that the events will take place in the open, in full view of the participants/athletes and Leaders ie there will be no situations where a single athlete/participant is alone with a single Leader and out of sight of others.
