### (i) Emergency Planning – Coronavirus

It was agreed by Members that in light of developments and all further meetings being ceased with immediate effect due to the Coronavirus Pandemic that a Business Continuity Motion to the Council be drawn up and gives the Clerk delegated authority to progress all on going matters and to authorize all regular payments and incur expenditure in line with the Council's budget. ### (ii) Seat on A38

Councillor B. Quantrill updated Members that the seat area has been decided and that Councillor B. Andrews and Councillor M. Parrett are working together to get the seat in place.

# (iv) Flooding at Dunkery Road

The Clerk has reported the silting of the field in Chapel Allerton and that the drain will need to be jetted once the field has been sorted to County Highways. The Clerk is waiting for a response - Noted.

# (v) Milestone Post along A38

The Clerk contacted County Councillor B. Filmer over the sudden disappearance of the Milestone Post along the A38. County Councillor B. Filmer has confirmed that the post has been taken away for maintenance and will be replaced in due course – Noted

# (vi) Overgrown Footpath along the A38

The Clerk has reported to County Highways the issue of the footpath overgrowing and restricting access for pedestrians. As yet there has been no response from County Council Highways. County Councillor B. Filmer said that he would take that back to County to see what the hold-up is in responding.

**Footpaths** – Councillor M. Parrett reported several footpaths with overhanging trees that need to be reported to the landowners so that they can be cut back or removed if necessary.

Highways – The state of the roads is an ongoing issue within the Parish and County Council Highways have been notified on numerous occasions but nothing appears to be done. Councillor I. Ham said that the road from his property on Quab Lane back out to Notting Hill Way is very dangerous there are several quite deep pot holes and the edge of the road is disappearing. Councillor B. Filmer made a note to take back to County Highways.

The Chairman Councillor B. Quantrill also took the opportunity to thank Councillor Ian Ham for turning out on Thursday morning in the cold and wet to try to find out if there was a hidden pipe under the road near the Windmill. The conditions were difficult with strong winds and so Councillor I. Ham said that he would try again at a later date.

**WWW & The Coombe** – Councillor T. Jones reported that there was another tree down up the Coombe. Members agreed that the Clerk write to DJ Dors and ask them to cut it back. Nothing to report. Councillor T. Jones said that he will be going up to the Coombe over the weekend to make sure that the gully is kept clear.

**Burials** – The Clerk reported the Notice Board would be fixed back in place once the weather improves.

**Neighbourhood Watch** – Councillor B. Andrews is continuing to send us through details of crimes committed and of suspicious vehicles.

**Farm Watch** – Councillor B. Quantrill reported that we all need to remain vigilant as there are still thefts of machinery and stock being taken from Farms.
