## 119. Matters Arising

## Minute 42 c) Rhiwfawr Park - Drainage

As a result of a meeting with the Clerk to Ystradgynlais Town Council the contact details of their technical advisor was provided in order to view the three drainage proposals. The advisor was contacted and unfortunately they are unable to take on any new clients however they were agreeable at a no fee basis to carry out an assessment and view the documentation. The recommendation from the technical advisor is to select the scheme proposed by Redwood Environmental. In addition to this they suggest that annual or biennial aeration of the field would be beneficial to consider in future years for all the solutions.

In addition to this a second technical adviser was approached to discuss the scheme who again supported that Redwood Environmental provided the most effective scheme.

Each of the companies were requested to provided contact details for referees who have had similar work that can be contacted and for a copy of the insurance. All have provided satisfactory insurance information. References have been received for Paul Fox (2), Kerry Jones (2) and Redwood Environmental (1) and all were satisfactory.

**Resolved** to select Redwood Environmental contractor and discuss the possibility of reducing the waste disposal, Heras fencing and welfare unit costs.

## Minute 57.3 Other Urgent Financial Matters – Christmas Lights

Contact has been made with Neath Town Council who have provided the details for the company they hire their Christmas decorations from. Neath Town Council have opted to have LED lights that have reduced the running costs and entered a three-year contract with Commercial Christmas who are based in Llanelli. A site meeting has been arranged for 23<sup>rd</sup> March to discuss what is possible.

## **Minute 64 Rhiwfawr Community Association**

The Association has identified a third holding trustee, the Trust Deed has been drafted and is currently with Carys Miles, NPTCVS. It is anticipated that the Trust Deed will be finalised in very soon. The accounts have been audited and three quotes have been obtained for the roof repair work. Paul Hinder, NPTCBC, has been contacted and he has stated that the grant decision would be quick.

#### **Minute 65 Rhiwfawr Play Park**

The grant application for third party funding made to NPTCBC East Pit Opencast Community Benefit Fund has been successful. The amount secured on a conditional offer is £2,330.39 subject to a successful WREN application. The outcome of the WREN grant application will not be known until 17<sup>th</sup> May. Further information has been requested by the WREN Grant Officer and this has been provided within the deadline.

#### Minute 111.1 Street Lighting - Harris Road

Cllr K Lloyd has provided an update. NPTCBC wish to upgrade the lamp posts but are in dispute with the landowner of the field opposite so matters have gone to the Legal Department. The problem is that that permission to change the light bulbs and upgrade the lamp posts cannot be separated. It needs to be established who owns the grassy verge and why the bulbs cannot be changed without intruding on the field. This can only be answered by NPT Lighting Dept Manager and he is not back from bereavement leave until 4<sup>th</sup> April. Ogwyn Williams and the residents have been updated.

#### **Minute 112.3 Grounds Maintenance Contract**

Invitation to quote for the grounds maintenance work was sent out 2<sup>nd</sup> February with a deadline of 9<sup>th</sup> March 2017. Four companies have submitted quotes.

The budget set is £4,268 for 2017/18. The guotes received are:

- Company 1 £4,310
- Company 2 £5,749.51
- Company 3 £6,040
- Company 3 £5,710.08

All of the companies are reputable and have the necessary insurance in place.

**Resolved** to select Company 1 for the grounds maintenance contract for demonstrating best value for money. This company is Wrenvale Nurseries and Landscapes.

The £42 shortfall is to be met from the free reserves.

## Minute 114.1. Gynol Road and Harris Road

The common land map has been received and it would appear that neither road is affected.

A response has been received from the solicitor associated with One Voice Wales regarding advice requested about the powers available to the Council to undertake work to the unadopted highways, Gynol Road and Harris Road. Below is the response received 27th February.

Client: Cwmllynfell Community Council

Subject Matter: Repairs to unadopted roads.

I have been allocated this request to advise upon and I have seen your email dated 20 February 2017 together with your email exchange dated between 10 and 14 February 2017 with the Community Clerk.

The issue in this request is whether the Community Council has the power to pay for repairs to unadopted roads in the community where those roads serve the general population as well as the immediate households. The Community Council has been in contact with the highway authority, Neath Port Talbot County Borough Council (NPTCBC) but that authority is not prepared to adopt the road or pay for repairs to it. The Community Council has obtained quotes for basic repairs to the two roads of £7,000 and £12,000 respectively.

I assume that the roads in question are highways albeit not ones maintainable at the public expense. By highway I mean a route over which the general public have a right to travel at any time without permission. As they are not maintainable at public expense the duty to maintain them lies with the owners of the land over which the road runs in that they have to keep it in a condition suitable for the traffic using it. The general rule is that when a highway has different landowners on each side those properties own the land to the middle line of the highway unless evidence proves differently.

Section 43 of the Highways Act 1980 permits a local council to make repairs to a footpath, bridleway or restricted byway that is maintainable at the public expense but beyond that a local council has no power to maintain a highway. The Power of Well-Being under section 2 of the Local Government Act 2000 (2000 Act) allows the Community Council to take any actions that it believes are for the economic, social or environmental well-being of its area, or some of the population, so long as there is no existing prohibition against the action in question. However, the Welsh Government guidance on the use of the Power of Well-Being (Statutory Guidance to Welsh Local Authorities on the Power to promote or improve Economic, Social or Environmental Well-Being under the Local Government Act 2000) issued in April 2013 states "This means that while the power to promote well-being is subject to such other powers that exist in primary or secondary legislation, it is not subject to limitations which might be implied or inferred from the way in which those powers have been drafted in existing legislation". Section 43 of the 1980 Act does not prohibit a Community Council from maintaining a highway, and therefore it is not a limitation that would exclude the Power of Well-Being.

As the unadopted road serves more than just the houses along it the Community Council could conclude that repairs to the roads were for the benefit of the area or the population. I am also told that the roads are used by non-residents to access other areas and that they therefore provide a benefit to the public at large. If this is the case then the Community Council should identify in the minutes which of the three areas of benefit (economic, social or environmental) covers the road repairs. The decision whether to use the Power of Well-Being and the benefit arising from that use are for the Community Council to decide and to justify if necessary.

However, the Power of Well-Being does not allow the Community Council to raise money so all expenditure must come from ordinary funds. The Power of Well-Being replaces the power under section 137(1) of the Local Government Act 1972 (1972 Act) but the limitation on spending under section 137 of the 1972 Act applies to the Power of Well-Being (as a pre-existing limitation) so the maximum amount that can be spent for the year 2016/2017 under the Power of Well-Being is £7.42 per elector. Any grants made under section 137(3) of the 1972 Act would also be included in this limit.

I hope that this clarifies the position but if the council requires any further information or advice please contact NALC again.
