## 96. <u>APOLOGIES</u>

Apologies for their absence were received from Councillors R Evans, V B Fox and D C Phillips.

## 97. DECLARATIONS OF INTEREST

Councillor Mrs M C Jones declared her personal interest in Agenda Item 6(b) – Application for Financial Assistance – Cwmllynfell and Rhiwfawr OAP Association – Samuels Hall.

### 98. MINUTES

**Resolved** that the Minutes of the Meeting of the Council held on the 15<sup>th</sup> December 2010, be confirmed and signed as a correct record.

## 99. MATTERS ARISING

## (a) Minute 88(a) – Western Valleys SRA - Cemetery Development

The Clerk reported that representations had continued to be made in respect of the application for part funding that had been made under the Western Valleys SRA. After corresponding on the 2<sup>nd</sup> November, 2<sup>nd</sup> December and the 17<sup>th</sup> January a response was received today from Mr Christopher Ashman, the Programme Director for the Western Valleys Regeneration Division. Unfortunately the response that had been received was that the project did not attract sufficient weight of priority for recommendation of approval to the Deputy Minister. The Programme Director indicated however that he would welcome the opportunity to meet the Council.

Mrs Gwenda Thomas AM had continued to make representations in support of the Council's application but she had similarly failed to elicit a response.

**Resolved** that efforts be made to convene a meeting at which Mrs Gwenda Thomas AM and Mr Christopher Ashman can be present to discuss how the community may benefit from the Western Valleys SRA.

### (b) <u>Minute 88(c) - Strategic School Improvement Programme – Consultation</u> <u>Document – YGGD Rhiwfawr & YGGD Cwmllynfell</u>

A letter dated 9<sup>th</sup> December 2010 had been received from Neath Port Talbot County Borough Council in which it was stated that the Council's Cabinet had considered all the views expressed during the formal consultation and had decided to continue with the proposal to the next stage, which was the publication of the statutory notice. The closing date for submitting observations would be the 14<sup>th</sup> February 2011.

**Resolved** that the Council's objection to the proposals affecting YGGD Cwmllynfell and the closure of YGGD Rhiwfawr be reaffirmed and further representations be made to Neath Port Talbot County Borough Council.

## (c) Minute 90 – Draft Health, Social Care and Wellbeing Strategy 2011 – 2014

The above draft strategy prepared by Neath Port Talbot County Borough Council was considered.

**Resolved** that the following comments be submitted to the County Borough Council:

"The Council is broadly supportive of the key priorities for improving health which are contained in the strategy but the Council wishes to remind the partners to the plan that General Practitioner provision in Cwmllynfell has undergone a disruptive transition in recent years and that the Surgery continues to be held in the premises of the former GP. The area and the patients in particular would benefit from the provision of modern health centre facilities. As such the agencies concerned are requested to examine the possibility of providing such facilities either separately or attached to other public facilities in the community".

## 100. <u>THE ROYAL BRITISH LEGION – "GREAT POPPY PARTY WEEKEND" 10<sup>th</sup> –</u> <u>12<sup>th</sup> JUNE 2011</u>

A letter dated 4<sup>th</sup> January 2011 was received from the Royal British Legion inviting the Council to participate in the above event to celebrate the Royal British Legion's 90<sup>th</sup> anniversary.

**Resolved** that enquiries be made of the local Royal British Legion Branch as to whether a local event is planned.

A communication was received from Neath Port Talbot County Borough Council indicating that funding had been secured for the above project which would involve the creation of a wildflower meadow on part of the park at Rhiwfawr. It was envisaged that the preparatory groundwork would take place at the end of February.

### (b) Budget 2011/12

The Clerk submitted his report on the review of the budget for the current financial year and the draft budget for 2011/12. Particular reference was made to the standing commitments such as grounds maintenance and the tendency to increase spending on grants year on year. Cwmllynfell Hall had requested the Council to increase its grant again during the coming year. The report also referred to the proposal to extend and improve the cemetery.

Three alternative draft budgets were presented for the Council's consideration so that the effect which various levels of expenditure would have on the precept could be assessed. A restrained approach to the budget would result in expenditure for the next financial year amounting to £31,991.35, consisting of £25,991.35 (revenue) and £6,000.00 (capital). The capital expenditure represented a 30% contribution by the Council towards expenditure of £20,000 on the cemetery. The remaining £14,000 would be met by a grant which Neath Port Talbot County Borough Council had approved. Other sources of grant were also being pursued to enable a more comprehensive scheme to be carried out to extend and improve the cemetery.

Estimated miscellaneous income, for 2011/12, including bank interest, amounted to £1,805.00 leaving net expenditure of £28,113.60 to be met from balances and the precept. The anticipated reserve at the  $31^{st}$  March 2011 which would be carried forward into 2011-12 was estimated at £55,253.24. A notification had been received from the Neath Port Talbot County Borough Council that the Council Tax Base for the community for 2010/11 would be 364.82.

### **Resolved** that:

1. the Budget for 2010/10 showing total expenditure of £31,991.35, consisting of £25,991.35 (Revenue) and £6,000.00 (Capital) be approved;

- a precept of £23,000 be made upon the Neath Port Talbot County Borough Council for the financial year 2011/12, which together with estimated miscellaneous income of £1,805.00 would leave £7,186.35 to be met from balances;
- 3. the following categories of investments be undertaken in 2011/12:
  - (i). deposits be made in a High Interest Deposit Bond (or similar) to a maximum of £45,000 for 6 months duration on each occasion, the timing to be reviewed according to Market Conditions;
  - (ii). deposits be made in a Business Money Manager Account (or similar) of all sums in excess of the working balance in the Council's Treasurer Account (normally £4,000 - £10,000) with the maximum figure reviewed at each renewal of the High Interest Deposit Bond and as necessary to take account of the cash flow requirements.

## (c) Applications for Financial Assistance

Consideration was given to applications for financial assistance.
