ATTENDING Councillor K Lloyd - Neath Port Talbot County Borough Council

70. APOLOGIES

Apologies for their absence were received from Councillors M Evans, R Evans and R P Morgan.

71. CHIEF INSPECTOR J WILLIAMS & SERGEANT J JAMES

The Chairman welcomed Chief Inspector Joanna Williams and Sergeant Jayne James. The officers had been invited to the meeting in response to the Chief Inspector's letter of introduction in which she had indicated that she had hoped to meet the Council. The officers introduced the discussions by claiming that crime figures were in general reducing. The Police service was also faced with the requirement to reduce budgets in order to achieve the savings of £71m that were required by 2018.

A discussion ensued and members raised the following matters and suggestions:

- Reintroduction of the "Blue Light Disco" at Cwmllynfell;
- Limited number of Police Stations open to the public at certain times;
- Perception by the public that crime was increasing and the fact that some crimes are not reported;
- Desire for police to be on the beat;
- Community Police Officer surgeries in the community;
- Notification of PACT meetings in the local press;
- The holding of public awareness sessions on drug misuse and "open days" on policing in the locality;
- Reintroduction of co-operation between Community Police Officer and farming community;

The Police Officers responded individually to the above-mentioned issues and in so doing provided the following explanations on policing practices:

- Consideration will be given to PCSOs holding "Blue Light Discos";
- 83% of calls made to the Police are non crime related;
- Public Call Centres introduction of new control system;
- Reduction in "front desk service" telephone call boxes to be provided;
- Important that crimes are reported as resources can only be allocated if reports have been received – co-operation from the community essential to make policing effective;
- No evidence that random Police patrols are effective in combating crime patrol duties carried out by PCSOs;
- Community Safety Department proving to be effective in combating crime;

The Chairman thanked the Officers for their attendance.

72. DECLARATIONS OF INTEREST

No declarations of interest were made at this juncture

73. <u>MINUTES</u>

Resolved that the Minutes of the Meeting of the Council held on the 17th September 2015 be confirmed and signed as a correct record.

74. MATTERS ARISING

(a) Minute 60(f) – Christmas Lighting Provision 2015

It was reported that Celtic Energy had agreed to provide a Christmas tree for Rhiwfawr again this year and that the necessary arrangements would be made for its installation. The Council had already decided that a live tree at Cwmllynfell be dressed with lights.

A communication dated 12^{th} October was also received from the Electrical Supervisor at Neath Port Talbot County Borough Council in which he indicated that he had been trying to obtain prices for the additional wrap around garlands that the Council had requested but had not been able to obtain the information. He had indicated however that it was possible to lend an extra eight garlands for installation on the existing steel poles. The cost for the additional work would be £431.28 which included erecting and removing the displays, the supply and carrying out of the electrical alterations required to adapt the columns.

Resolved that:

- 1. the arrangements for the installation of a tree at Rhiwfawr be noted;
- 2. the quotation received from Neath Port Talbot County Borough Council in the sum of £431.28 for the additional work as described above be accepted.

(b) <u>Minute 62 - Welsh Government's Draft Directions to the Local</u> <u>Democracy and Boundary Commission</u>

Consideration was given to submitting comments in respect of the above direction.

Resolved that the following comments be submitted to the Welsh Government:

The Council notes that the Draft Directions are based on the Welsh Government's stated preferred configuration for the future of Local Authorities in Wales following consultation on their "Reforming Local Government - Power to Local People White Paper". The preferred configuration and the resultant directions on the number of councillors for a local authority raises questions on the White Paper's claimed objective to "power local people" as the configuration fails to acknowledge the natural building blocks formed by communities. The proposal that each ward should have roughly the same number of electors per elected representative would also diminish the democratic representation that results from utilising identifiable communities as the unit which forms the electoral division that is represented by an elected member(s). The directions that are proposed therefore prevent the Commission from bringing forward proposals that

would ensure that truly democratic, effective and convenient local government is delivered as it is proposed that areas that are different in character are thrust together. Isolated communities are likely to suffer as a result of being part of a large conurbation. The Community of Cwmllynfell comprising the rural villages of Cwmllynfell and Rhiwfawr is one such community. There is however scope for making some improvements as it is a fact that in many parts of Wales communities are divided by an artificial boundary both at Community Council and Principal Authority level. An adjustment of such boundaries away from valley floors to the watershed of hills and mountains would improve community identity and governance. The implication for Parliamentary Constituency Boundaries should also factor into the guidance and the reconfiguration of local authorities should possibly be delayed until those boundaries have been determined.

(c) <u>Minute 63 - "Shared Purpose: Shared Future" – Draft Statutory Guidance</u> for The Well-Being Of Future Generations (Wales) Act 2015

Consideration was given to submitting comments in respect of the above draft guidance.

Resolved that the draft guidance be noted.

(d) Minute 68 – Rhiwfawr Hall

It was reported that a public meeting had been held recently and that a new management committee for the hall had been formed.

Resolved that the next meeting of the Council be held at Cwmllynfell as Rhiwfawr Hall is currently in transition.

(e) <u>Minute 68 – Cwmllynfell Cemetery – Proposed Commemorative Edging</u> <u>Stones and "Grow Wild" Seed Kits</u>

Consideration was given the feasibility of allowing commemorative edging stones to be installed at the cemetery.

A communication dated 13th October 2015 was received from the Grow Wild Wales Partnership Manager in which details were provided of the opportunity to register for the 2016 free "Grow Wild" seed kits. A communication dated 13th October was also received from Groundwork announcing the green space project which they were organising in partnership with Tesco to fund capital projects that provide a community benefit.

Resolved that a meeting of the Cemetery and Environment Committee be held on Monday 26th October 2015 to discuss:

- (a) the feasibility of allowing commemorative edging stones to be installed at the cemetery;
- (b) the potential of taking advantage of the free "Grow Wild" seed kits and the Groundwork Green Space Project to enhance the undeveloped area within the cemetery as a wildflower meadow.

75. ACTIVE TRAVEL EXISTING ROUTE MAP

A communication dated 21st September 2015 was received from Neath Port Talbot County Borough Council in consultation on the above-mentioned map which was being prepared in accordance with the requirements of the Active Travel (Wales) Act 2013. "Active Travel" as defined in the act meant walking and cycling for everyday short distance journeys such as those to school, work or for access to shops or services. The settlements to be included in the maps had been designated by the Welsh Government and were derived from the Office for National Statistics' Built Up Areas definition. The Community of Cwmllynfell had not been included in the map. Comments had been invited by the 14th December 2015.

Resolved that consideration of the matter be deferred until the next meeting.

76. <u>PREPARING FOR PUBLIC SERVICES BOARDS CONFERENCE – CARDIFF –</u> <u>26TH NOVEMBER 2015</u>

Resolved that the invitation form the Minister for Public Services for the Council to be represented at the above conference be noted.

77. GAMBLING ACT 2005 - DRAFT STATEMENT OF PRINCIPLES - 2016

Resolved that the letter dated 23rd September 2015 from Neath Port Talbot County Borough Council in consultation on the above-mentioned draft principles be noted.

78. NEATH PORT TALBOT CVS

A letter dated 2nd October 2015 was received from Neath Port Talbot CVS in which they requested to meet with the Council to explain their role and the work that they did in the community and how they and the Council could work more effectively together to help meet the ever increasing challenges facing communities.

An invitation had also been extended to the Chairman to attend their Annual General Meeting on the 10th November.

Resolved that representatives of Neath Port Talbot CVS be invited to the next or next following meeting of the Council whichever suits their arrangements.

79. <u>MID AND WEST WALES FIRE AND RESCUE SERVICE – DRAFT ANNUAL</u> <u>IMPROVEMENT PLAN 2016/17</u>

A communication dated 6th October 2015 was received from the Fire and Rescue Service in which their 12 strategic objectives for the year 2016/17 were set out. Comments were invited by the 11th December 2015.

Resolved that the matter be noted.

80. INDEPENDENT REVIEW PANEL – ANNUAL REPORT 2016/17

A communication dated 8th October 2015 together with the above draft report was received from the Independent Remuneration Panel. The report included details of payments to members of community and town councils.

Resolved that the report be noted
