MINUTES OF THE MEETING HELD AT CWMLLYNFELL HALL ON THURSDAY 21st JANUARY 2016 AT 6.30 P.M.

127. CONDOLENCES - THE LATE MR DOUGLAS LLOYD

The Chairman referred with deep regret to the fact that Councillor David Lloyd's brother had passed away.

All present stood in silent tribute as a token of respect.

128. APOLOGIES

Apologies for their absence were received from Councillors R M Davies, T H J Kendrick and Councillor K Lloyd, Neath Port Talbot County Borough Council.

129. DECLARATIONS OF INTEREST

No declarations of interest were made at this juncture

130. MINUTES

Resolved that the Minutes of the Meeting of the Council held on the 17th December 2015 be confirmed and signed as a correct record.

131. MATTERS ARISING

(a) Minute 111(c) iii – Community First Responders

A communication dated 17th January 2016 was received from Mr J Dean Llewellyn, Director of the All Wales Ambulance Service Ltd in which he indicated that he would be delighted to attend the meeting of the Council on the 18th February to discuss the possibility of extending the Ystradgynlais First Responder Scheme to cover areas up to and including the community of Cwmllynfell and also the installation of Automated External Defibrillator in the community.

Resolved that the necessary arrangements be made for Mr Llewellyn to attend the meeting on the 18th February.

(b) Minute 111(b) - East Pit - Draft Community Benefit Scheme

Copies of correspondence that had taken place between the Project Development and Funding Manager, Neath Port Talbot County Borough Council and County and County Borough Councillors representing the communities affected, were received. The Development and Funding Manager had proposed that a meeting be held to discuss the alignment of the Additional Community Contribution (£275,000 to be managed by NPTCBC) with the Community Benefit Scheme (£200,000 to be managed locally). He had also made suggestions on the representatives to attend the meeting including County and County Borough Councillors, a representative of Celtic Energy, representatives of the three

community councils, including the Clerks and possibly representatives of the Site Liaison Committee.

The Clerk of the Council suggested to the Council that the terms of the Section 106 agreement that had given rise to the Community Benefit Scheme and Additional Benefit Contribution was too vague in its definition as it had failed to specify exactly how the scheme should operate. It was also unacceptable that the Head of Planning, Neath Port Talbot County Borough Council in a communication dated 14th January 2016 to Councillor Arwyn Woolcock (representative for Lower Brynaman and Tai'rgwaith) had claimed that "the Planning Authority had no responsibility/remit associated with the implementation of the community benefit scheme".

Resolved that the Chairman, Vice-Chairman and Councillor D C Phillips be authorised to attend the proposed meeting on behalf of the Council.

(c) Minute 111(c) – Rhiwfawr Community Association

A communication dated 19th January 2016 was received from the Chairman of the Rhiwfawr Community Association in which he enquired whether the Clerk could attend their next meeting on the 25th January 2016. The Clerk had responded indicating that the request would be conveyed to the Council but also emphasising that it was the Council's wish for representatives of the Association to attend a meeting of the Council so that all members of the Council could have the opportunity to learn of the proposals that the Association had for Rhiwfawr Hall.

Resolved that the Council's invitation for representatives of the Association to attend the meeting of the Council on the 18th February be reaffirmed.

(d) Minute 111(d) – Youth Representation

It was reported that no applications had been received from youths interested in participating in the Council's scheme for youth representation. The invitations that had been circulated had coincided somewhat with the Christmas holidays so it was suggested that the closing date be extended until at least mid February.

A communication was also received the Young Trustee Co-ordinator of the Children's Trust Unit in which she enquired with regard to the Council's progress in developing youth engagement and offering to meet with the Council.

Resolved that:

- 1. the closing date for the receipt of applications in relation to Youth Representation be extended as suggested;
- 2. the Young Trustee Co-ordinator be advised of the situation.

(e) Minute 120 - Draft Local Government (Wales) Bill - Engagement Event - Liberty Stadium, Swansea - 2nd February 2016

An invitation was received from the Welsh Government for the Council to be represented at the event.

Resolved that the Chairman, Councillor J C Rees, Vice-Chairman Councillor R P Morgan and Councillor D C Phillips be authorised to attend the event.

(f) Minute 124(a)i - Financial Matters – Application for Financial Assistance Cwmllynfell Hall

A communication dated 11th January 2016 was received from the Secretary of Cwmllynfell Hall in which it was indicated that their accounts for the period ending 30th September 2015 were being prepared and would be submitted as soon as possible together with their application for financial assistance for 2016-17. It was also indicated that the hall had been notified by Neath Port Talbot County Borough Council that the funding for the year would be reduced by £7,000

Resolved that the information be noted and enquiries made of Cwmllynfell Hall as to whether their agreement with the County Borough Council as trustees has been varied to take account of the reduction in financial support.

132. THE QUEEN'S 90th BIRTHDAY BEACONS - 21st April 2016

Information was received from One Voice Wales in connection with the arrangements for the lighting of beacons to mark the Queen's 90th Birthday.

Resolved that the information be noted.

134. LOCAL GOVERNMENT ACT 1972 - SECTION 137 - EXPENDITURE LIMIT FOR 2016-17

A letter dated 18TH January 2016 was received from the Welsh Government in which a notification was given that for the financial year 2016 -17 the discretionary expenditure limit for the purposes of section 137 would be increased to £7.42 per local government elector.

Resolved that the matter be noted.

(b) Investment Strategy - 2016-17

Resolved that the following categories of investments be undertaken in 2016/17:

- 1. deposits be made in a Deposit Bond (or similar) to a maximum of £45,000, the duration on each occasion to be reviewed according to market conditions;
- 2. deposits be made in a Business Money Manager Account (or similar) of all sums in excess of the working balance in the Council's Community Account (normally £4,000 - £10,000) with the maximum figure reviewed at each renewal of the Deposit Bond and as necessary to take account of the cash flow requirements.

(c) **Budget 2016/17**

The Clerk submitted his report on the review of the budget for the current financial year and the draft budget for 2016/17. Expenditure for 2016/17 was estimated at £33,332.51 and miscellaneous income including bank interest was estimated at £2,055.00 leaving net expenditure of £31,277.51 to be met from balances and the precept. The anticipated reserve at the 31st March 2016 which would be carried forward into 2016/17 was estimated at £64,326.77. provision had been made for capital expenditure during the coming year. notification had been received from the Neath Port Talbot County Borough Council that the Council Tax Base for the community for 2016/17 would be 367.62. The estimated expenditure for 2016/17 was summarised as follows:

- 2. the applicants be also advised to consider submitting an application for a grant under the Welsh Church Acts which is administered by Neath Port Talbot County Borough Council.
