MINUTES OF THE MEETING HELD AT RHIWFAWR HALL ON THURSDAY 21st APRIL 2016 AT 6.30 P.M.

176. DECLARATIONS OF INTEREST

No declarations of interest were made at this juncture

177. <u>MINUTES</u>

Resolved that the Minutes of the meeting of the Council held on the 17th March 2016 be confirmed and signed as a correct record.

178. MATTERS ARISING

(a) Minute 165(a)- Automated External Defibrillators

A communication dated 29th March 2016 was received from 'Welsh Hearts' in response to the Council's enquiry in which it was indicated that the organisation was able to supply two Automated External Defibrillators at a cost of £1,800. The cost included maintenance of the equipment and training. The defibrillators would also need to be housed in heated and alarmed storage cabinets.

The Clerk reported that he had written to the Welsh Ambulance Service in order to ascertain whether the service had any recommendations and advice in connection with the installation of such equipment. It would also be necessary to seek co-operation from Cwmllynfell and Rhiwfawr Halls so that the units could be located outside the halls.

Resolved that:

- 1. the response of the Welsh Ambulance Service be awaited;
- 2. enquiries be made of Cwmllynfell and Rhiwfawr Halls as to whether they would be prepared for the equipment to be installed at those locations.

(b) Minute 165(b) - East Pit – Draft Community Benefit Schemes

The notes of the joint meeting of Community Representatives, Celtic Energy and Neath Port Talbot County Borough Council that had been held on the 23rd March 2016 had been circulated. It had been agreed at the meeting that the £50,000 per community (4 communities) under the Community Benefit Scheme would be paid to the respective Community Councils. It had also been agreed at the meeting that the revised Additional Community Contribution of £70,000 per community would also be transferred to the respective Community Councils in two equal sums of £35,000 in July 2016 and July 2018 for distribution. A communication dated 21st April had however been received from Neath Port Talbot County Borough Council in which it was indicated that the Additional Community Councils but would be administered by Neath Port Talbot County Borough Council in

accordance with the terms of the Section 106 agreement. The receipt of the Community Benefit sum from Celtic Energy was currently awaited.

Resolved that:

- 1. the information be noted;
- 2. bank accounts be opened in respect of the Community Benefit Scheme.

(c) Minute 165(c) - Appointment of Clerk of the Council

It was reported that the further advertisement for the post with an extended closing date had not as yet been placed as a member of the Council had expressed an interest in the post.

Resolved, on the recommendation of the Clerk of the Council, that advice be sought on the matter from One Voice Wales and the Society of Local Council Clerks.

(d) Minute 165(g) – Footbridge on FP14Lgk – Cwmllynfell

A communication dated 21st April 2016 was received from Carmarthenshire County Council in which it was indicated that an inspection of the bridge had confirmed that the structure was stable and therefore satisfactory for public pedestrian use. However, given the age of the bridge and the high level of use it received, it was intended to put forward a recommendation for priority to be given to its renewal this year.

Resolved that the information be welcomed.

(e) Minute 171 – Youth Representative

Resolved that it be noted that arrangements would be made as soon as possible to interview Keelan Rochard who had expressed an interest in becoming a Youth Representative.

(b) Grow Wild Wales

It was reported that seeds had been received from Kew Gardens and that pupils of Cwmllynfell School had participated in the sowing at Cwmllynfell Cemetery.

Resolved that the matter be noted.

(c) <u>Cwmllynfell Cemetery</u>

It was reported that a grave at Cwmllynfell Cemetery was in a dilapidated state and that enquiries were being pursued to ascertain ownership.

Resolved that arrangements be made for urgent repairs be carried out to make the grave safe.

(d) <u>Rural Development Plan – "Working with Nature"– "Cwmllynfell and</u> <u>Rhiwfawr Environmental Scheme" (Cares)</u>

It was reported that Neath Port Talbot County Borough Council had indicated that more Community Councils had become involved in the project and that it was intended to seek additional European funding. It was anticipated that the scheme would start in August and the Council had been asked to make arrangements with regard to the payment of its approved contribution of £6,000 (Minute 42 of the meeting of the Council held on the 16th July 2015 refers).

Resolved that the Council's contribution be spread over two years.

- 2. advice be sought with regard to the drainage at Rhiwfawr Park and the issue of dog fouling be raised with Neath Port Talbot County Borough Council.
