On 12th January 2017 Cllrs D C Phillips, J C Rees and Mrs C Phillips and the Clerk met with Wayne Curtis and Lynne Evans, NPTCBC to view cemetery management systems that are in place.

As a result of the meeting it has been identified that the priority work that needs to be undertaken is:

- For the site to be mapped by Mrs C Phillips. Mrs C Phillips has agreed to begin this work.
- The development and adoption of a set of policy, processes and paperwork needs to be created in order to manage the new internments and any re-opening of the graves. This will begin to ensure that that future Health and Safety of the cemetery is being planned for. Once adopted the funeral directors, stone masons and grave digger will need to be contacted to ensure that all will adhere to the new systems and complete the necessary paperwork. NPTCBC have provided cemetery management information that they use as a burial authority. Research has also begun into other Community / Town Councils that manage cemeteries. Note it is anticipated that once the new management processes are in place that the cemetery fees may require reviewing again.
- It is recommended that the Institute of Cemetery and Crematorium Management membership is taken out at a cost of £90 per annum.
