
APPORTIONMENT of RENT CHARGE, in lieu of TITHES, of the Parish of



Parish of Saint Tudy, in the County of Cornwall, was, on the Twentieth Day of August, in the Year of our Lord One Thousand Eight Hundred and Thirty-nine, confirmed by the Tithe Commissioners for England and Wales, o which Award, with the Schedule therein comprised, the following is a Copy;—

Assistant Tithe Commissioner, according to the Provisions of the Act for the Commutation of Tithes in England and Wales, and have also been duly appointed to ascertain and Award the Total Sum to be paid by way of Rent-Charge, instead of the Tithes of the Parish of Saint Tudy, in the County of Cornwall.

AND WHEREAS, I have held a Meeting in the said Parish, touching the matter aforesaid, of which Meeting due notice was given for the information of the Landowners and Tithe Owners of the said Parish.

AND WHEREAS I have duly considered all the allegations and proofs tendered to me by all parties interested, and have myself made all enquiries touching the premised subject, which appeared to me to be necessary.

AND WHEREAS I find that the estimated Quantity in Statute Measure, of all the Lands of the said Parish, (the whole of which are subject to the payment of Tithes,) amounts to Two Thousand Six Hundred and Thirty nine Acres, which are cultivated as follows (that is to say)

Two Thousand Five Hundred and Nineteen Acres as Arable Land,
Fifty Nine Acres and Three Roods as Meadow,
Thirty Acres as Orchard, and
Thirty Acres and One Rood as Wood and Plantation.

AND WHEREAS I find that the Rector of the said Parish, for the time being, is entitled to all the Tithes thereof.

NOW KNOW YE, that I, the said George Louis, do hereby Award that the Annual Sum of Six Hundred and Forty Three Pounds, One Shilling and Six Pence, by way of Rent-Charge, subject to the Provisions of the said Act, shall be paid to the Rector of the said Parish, for the time being, instead of all the Tithes arising from all the Lands of the said Parish (except the Glebe).

AND that the further Annual Sum of Nine Pounds shall be paid to the said Rector, for the time being, by way of Rent-Charge, subject to the Provisions aforesaid, in lieu of the Tithes of the Glebe Lands of the said Parish, when not in the occupation of the Rector himself, and a proportionate part of the said last mentioned Rent-Charge, for any part of the said Glebe Lands, as may at any time not be in the occupation of the Rector Himself.

IN WITNESS whereof, I have hereunto set my hand, the second day of August One Thousand Eight Hundred and Thirty Nine.

Gross Rent-Charge payable to the Tithe-owner in lieu of Tithes, for the Parish of Saint Tudy, in the County of Cornwall, (including Tithe of Glebe) Six Hundred and Fifty Two Pounds, One Shilling and Six Pence.
