### **Farewell to Tom and Welcome Diana**











# **Fuel Poverty**

Caroline Clark, Christine Wilson and Tom Berney met the Scottish Parliament's Local Government and Communities Committee to discuss their scrutiny of the draft Fuel Poverty (Target, Definition and Strategy) (Scotland) Bill. SOPA later submitted written comments on the Bill which is aimed at eradicating fuel poverty by improving the fuel efficiency of Scottish housing. We welcomed the objectives of the bill, as the unaffordable cost of heating is regularly raised by older people. However, against a background of hundreds of thousands of Scots living in fuel poverty and 35% of winter deaths being from cold and damp related lung conditions like flu and pneumonia we expressed our doubts that simply improving fuel efficiency would be an adequate solution.

75% of all deaths in the winter months are people aged over 75 and that 35% of deaths are due to environmental related lung conditions like flu and pneumonia.
