Executive Summary

Burray Community Association (BCA) commissioned Voluntary Action Orkney (VAO) to identify options and propose recommendations for improving, upgrading and/or expanding community facilities in Burray to meet the needs of local residents. For the purposes of this report, recommendations are confined to the two existing assets managed by BCA, being the Village Hall and the Family Playpark.

Key Recommendations

The Village Hall Building

Upgrade/improve the energy system to increase efficiencies and reduce running costs. This could include:

- Upgrade aging wind turbine and install solar panels on south facing roof area;
- Install storage batteries in rear (south) compartment under side of hall building; and
- Replace control system for integrated wind/solar generation

Change to a more cost-effective heating system in order to make the facility more comfortable and usable during the colder winter months. This could include:

- Install air source, or ground source, heat pump(s) and introduce, or improve, the internal wall insulation
- Add optimum, local time, start/stop and thermostatic controls to the heating system

Make alterations to the internal physical infrastructure of the building to better optimise storage and user group areas. This would be best achieved through:

Reconfiguring the men's and women's toilet and shower areas.

The Family Playpark

Upgrade and/or refurbish the play equipment and the crazy golf course:

- Reduce maintenance and repair costs to aging play equipment;
- Ensure compliance with continually changing safety requirements; and
- Re-open the Crazy Golf course to paying visitors and benefit from an additional income stream

Other Recommendations

Forward Action Plan

Develop a structured forward action plan to address the key areas identified in the summary above. The plan must have short, medium and long term SMART targets. It needs to be clear and transparent about what can be realistically achieved.

Community Support

Feedback to the Community and Hall User Groups, sharing the findings from the survey. Communicate by regular updates to maintain the momentum and enhance the good will and support that has been shown to date.

Background

Burray Community Association (BCA) is a Scottish Charitable Incorporated Organisation (SCIO) and has been registered since 2014.

The BCA committee is elected from the membership, and a Board of Charity Trustees is also elected by the membership and embedded within the committee as full committee members.

BCA runs the Burray Village Hall and the Family Playpark Area on behalf of the residents of Burray.

BCA has become increasingly concerned in recent times about the status of the facilities in terms of aging equipment, an expanded usage of the hall for additional activities which are needing to be accommodated and the reducing time left on the contract for energy produced by the Association's wind turbine which would have a negative future benefit on income levels.

In October 2022, BCA developed a scope of work (see Appendix 1) and approached Voluntary Action Orkney (VAO) to undertake a community engagement project. Prime components of the project were identified as;

- a survey of the local community and the groups who currently use the village hall in order to better understand their expectations;
- a technical inspection of the hall and the playpark area to better understand the timescales and challenges of the existing facilities; and
- an examination and analysis of the BCA's past, current and projected future financial situation

This report outlines the methodology undertaken and results of the community engagement project, along with a series of recommendations and proposals for BCA to explore further and take forwards.

Methodology and Information Gathering

Community Survey

An introductory meeting was arranged between VAO and BCA, where the nature, scope and the purpose of the project were discussed and agreed.

Two survey questionnaires were developed for

- Community Individuals
- Hall User Group Representatives

Over 80 survey forms were completed, utilising the online Survey Monkey tool primarily, and hard copies were also made available. They have provided an excellent overview of how the community feels about the Hall and the Playpark, including what is good about the existing facilities, what needs improvement and what Burray residents would like to see provided in the future.

The survey ran for 4 weeks and VAO met with the BCA committee after analysing the results of the surveys to share and discuss the general themes that had emerged from the surveys prior to issuing the first draft of this report.

Technical Inspection

A site visit was made by VAO, supported by Roger Jackson from the BCA committee. The hall was in use at the time by a children's group involved in a wide range of play activities.

Facilities inspected and issues discussed included:

- Electricity supply, distribution, wind turbine generation and current Feed-In-Tariff (FIT) arrangements;
- Heating systems storage heaters from wind turbine and (more expensive)
 wall heaters from main electricity supply. It was noted there was no timer or
 thermostatic control for either system;
- The latest Energy Performance Certificate (EPC) for Burray Hall see Appendix 2;
- Floor layout in the hall, including kitchen, toilets, showers and storage rooms;
 and
- Playpark area comprising a walk round of toilet block, all play equipment and the crazy golf course.

BCA Finances

A summary of BCA finances from 2014 to date was provided to VAO (attached at Appendix 3) which gave a clear and helpful guide as to regular running costs, income levels alongside specific information on the financial aspects of previous projects and upgrades.

Outcomes and Analysis

Community Survey

A total of 84 community surveys were received and 10 surveys were completed by user groups. This is a significant response rate (the population of Burray totals around 400 people) and it is felt that the number of completed surveys gives a comprehensive and reliable overview of the thoughts, opinions and aspirations of Burray residents in relation to the future of the Burray Hall and Playpark. A full breakdown of the responses is available at Appendix 4 (Community Individuals) and Appendix 5 (Hall User Groups) to this report.

There is an overwhelming level of positivity and warmth shown in the surveys. Residents feel that the Hall is the centre of community life and provides an essential space for social activities for local residents. Only one respondent stated that they do not use the Hall, and 36% of respondents use the Hall on a weekly basis. 99% of respondents would miss the Hall if it was not there.

Respondents use the Hall for a variety of activities, and 95% felt that the Hall is a good venue for the type of activities they use it for.

Overwhelmingly, the **key physical improvement that would increase the quality of the venue for respondents was improved heating (61%).** Cheaper hire charges (25%) and better publicity of events (21%) were also cited as suggestions that would improve the venue. These improvements were also echoed by the responses to the User Groups Survey.

A number of activities were highlighted as being those that respondents would like to see take place at the Hall in future. In particularly high numbers these included arts and crafts workshops and craft sales, after school activities (particularly for primary age children), adult education classes and a community cinema.

58% of respondents stated that they were also users of the Play Park, with **53% of those confirming that they use the Play Park once a week**.

A lot of suggestions were made about how to improve the Play Park, including suggestions about new equipment and activities as well as improvements to existing activities such as the Crazy Golf course.

Residents said:

- The Hall is the heart of the community
- People feel connected to their community through the events and activities that take place at the Burray Hall
- The facilities are good, especially the kitchen
- The Hall needs some improvements, in particular better heating and additional storage
- Reduced hire charges would be helpful
- Residents would like to see more activities such as art and craft workshops, after school activities and adult education classes
- The Playpark is well used and liked

 New equipment would improve the Playpark, alongside a refresh of the Crazy Golf

The BCA Committee should take great heart from the number of people who took the time and effort to complete the surveys, and also from the responses to the surveys themselves. The Burray Hall has a very real and clearly articulated importance to and for the community and is at the heart of community life.

Technical Considerations

Heating and Energy

The key area of improvement identified is in relation to the heating of the Hall. This chimes not only with the community but to user groups as well, and there was mention of several groups that have relocated their activities to other venues due to issues with the heating.

This issue was raised as part of the site visit, as being something that the BCA Committee wants to address. The results of the survey, therefore, reinforce the existing thoughts of the Committee rather than providing any surprises. A recent Energy Performance Certificate (Appendix 2) also substantiates the identified poor performance of the heating.

Heating for the Hall comes primarily from a wind turbine, which directly provides the electricity to the Hall's large storage heaters, and also provides an income to the BCA in the way of a Feed-In-Tariff (FIT). Additional wall heaters compensate when the storage heaters are depleted and the Hall is cold.

The FIT contract for the wind turbine ends in 2027 and it's uncertain whether or not BCA will continue to receive an income from it after that date. In the meantime the aging turbine is likely to require additional expenditure on repairs and maintenance.

The current fixed term electricity tariff ends in 2024 so it's vital that a succession plan is put in place to reduce energy requirements and/or to increase the ability for the Hall to produce its own renewable energy. This can be achieved by installing solar panels, storage batteries and heat pumps. This in turn has the potential to replace, and possibly increase, the income stream currently provided by the wind turbine.

Physical Infrastructure

Usage of Burray Village Hall has changed somewhat since it was most recently renovated and updated. A significant amount of space is currently taken up with separate men's and women's toilet and shower facilities. The showers are not used to the same extent as previously, with most people taking part in physical activity and exercise going home to shower.

A lack of storage for equipment used on a regular basis by user groups is an issue. Groups do want to be able to leave their materials and equipment at the Hall rather than bring it each week and then remove it again.

Should work be undertaken to reconfigure some of the internal space in the Hall to reduce shower facilities and increase storage, the Burray Hall Committee would be able to encourage more regular use of the Hall and enable a wider range of activities as identified through the survey results.

The equipment and facilities made available to the public at the Playpark are aging and require regular and increasing maintenance. This will continue to have a detrimental impact on Hall finances as time moves forwards. It is also potentially a concern in terms of public safety.

BCA Finances

A financial summary was provided (attached at Appendix 3) which outlined the financial position between 2014 and 2022. This summary gives a good long-term view of the financial position and the benefit, in particular, that is derived from the wind turbine contract.

The Feed in Tariff (FIT) income for the wind turbine over the 2014-2022 period was £20,300. Without this income and the one-off Covid support payment, the Hall would have had a deficit of £24,000 for the same period. With the turbine income and the Covid support payment the net surplus for the period was £7,400.

This clearly demonstrates the negative impact the Hall will face when the turbine contract comes to an end in 2027. It is imperative that work is undertaken to improve the energy efficiency of the Hall as well as find an alternative source of income to replace the turbine income.

A number of funding streams are available to community groups and charitable organisations to make Halls more energy efficient and support the Net Zero agenda. The combination of practical evidence (through the EPC report) and the high level of responses identifying heating to be an issue, and the threat caused to the future of the Hall because of the ending of the turbine contract should support the committee to make a very strong case for funding.

Options

Any options appraisal would normally include an option to "do nothing".

But in this case, a "do nothing" scenario would leave the Hall in financial deficit within four to five years, with the situation becoming catastrophic from 2027 onwards.

The FIT contract with the wind turbine ends in 2027. This gives the BCA Committee a good period of time to plan and act to mitigate against the loss of income. But work needs to start now to ensure a smooth transition to a new income model and a more energy efficient heating system.

Recommendations

Develop a Forward Plan

Create a forward action plan for the Association, with short, medium and long term SMART targets. This can include building improvements and activities and enables the Association to be clear and transparent about what it hopes to achieve. This can be reported and updated at each AGM. The Forward Plan should enable the BCA Committee to explore and conclude:

How does BCA want to enable additional activities identified in the survey?

- direct provision by committee members?
- external providers hire the hall and use its facilities?
- a mixture of both?

From the activities identified in the survey results

- which are achievable in the short term?
- which require improvements to the building?
- which are not practical to take forward?

Feedback to the Community and Hall User Groups

Hold an event to share the findings of the surveys, thank people for taking part, and share plans identified in the forward plan for the future of the Hall and Play Park. This could take place on the back of an event that is known to be well attended.

Make contact with the individuals who stated an interest in supporting the delivery of activities or joining the Committee – try not to lose the momentum and good will that has been shared through the survey.

Heating and Reducing Energy Costs

Engage with Local Energy Scotland regarding the potential for funding through the CARES programme.

Grant funding, advice and support is available to community organisations, charitable organisations and faith groups that want to decarbonise their community buildings by installing low carbon or renewable energy systems, such as heat pumps or solar panels. Building and Playpark Improvements

1. Engage with Orkney Islands Council regarding funding for Hall and Play Park improvements. This should initially include funding towards a feasibility study.

A new tranche of funding for the CDF was approved by the Council in December 2022. The new guidance is not yet available on the OIC website but can be sought from the Economic Development Service.

SCOPE OF WORK FOR COMMUNITY SURVEY

Burray Community Association SCOPE OF WORK FOR COMMUNITY SURVEY October 2022

1. Purpose

Identify and analyse the community and social needs of the people of Burray in order to support the future development of a strategy for the provision of improved local amenities and services

2. Background

Overview

In recent years, the Burray Community Association (BCA) has raised considerable sums for upgrades and improvements to the benefit of Burray village and surrounding area residents. This includes, but is not limited to;

A new children's playpark incorporating a crazy golf course
Roof replacement and efficient lighting upgrade for the village hal

In addition, the BCA committee manages the provision and safety of the playpark and village hall for regular use by a wide variety of different local community groups. The hall is also used for public and private events provided by third parties under the auspices of the committee

Finances

Analysis of the BCA's finances, shows increasing costs for maintaining the hall and playpark, against a diminishing income. The latter is primarily derived from the day-to-day use of the hall and its facilities, together with regular Feed In Tariff payments from an aging wind turbine.

Over the six years pre-covid, the deficit between income and costs totalled £6k. This equates to an average deficit of £1000/year, currently funded by the BCA bank account. This will be unsustainable over the longer term, and the situation is under additional threat by uncertainty of the condition and reliability of the wind turbine.

The short term financial goal of the BCA committee is to reduce the annual deficit to zero. Thereafter, improved and enhanced facilities will lead to wider usage and higher income

Wind Turbine

The wind turbine is over 14 years old now. It is the main source of energy for heating the hall and also provides a Feed-In Tariff (FIT) income of approximately £2k/year. If it fails, the BCA not only loses the income while the turbine's offline, but also incurs increased electricity supply costs for heating the hall. As such, the BCA committee needs to keep substantial funds available for emergency repairs if/when required urgently. Inspection and preventative maintenance is regularly undertaken to mitigate the risk of failure. But this also involves additional expense.

A strategy for the long term practical future for the wind turbine needs to be considered and agreed by the BCA committee in the near future

Community Demographic and Associated Needs

There is a perceived demographic trend towards an older population in the region generally, and this is currently influencing the bias for associated community provision and services. But there's also an increase in new housing and more people moving into Burray and the surrounding areas.

In order to develop a strategy for expansion or improvement, the committee needs greater understanding of the *actual* population demographic together with its indicative needs.

3. Objective

The committee is undertaking a review of the Burray Hall premises and local facilities generally, in order to identify changes that will benefit the surrounding community.

Key to this, is understanding how the current community facilities are perceived and experienced by as many Burray residents as possible, in order to develop a specification for a programme of minor and/or major change. This in turn will enable the committee to seek necessary funding for such change from local, regional or national sources

The committee also wishes to engage representation from a wider range of local residents in the running and maintaining of its community facilities and amenities.

4. Evidence Gathering

The base specification for gathering data will require, but will not be limited to,;

- a survey of the community and the groups who currently use the village hall in order to understand their expectations
- a technical survey of the hall and the playpark to understand the timescales and challenges of the existing facilities

It is envisaged the community survey will be designed after initial consultation with the BCA committee, then reviewed and approved by the committee before distribution

Thereafter the community survey would be conducted digitally (online) and supported by the distribution and collection of hardcopy leaflets, using high profile distribution points and/or postal services. In order to achieve a minimum 40% participation overall input, a community event should be considered.

Surveyors might also wish to interview current and past BCA committee members in order to gain additional insight from previous practical experience?

5. Deliverable(s)

An evidence based report to identify options, and propose a recommendation, for improving, upgrading and/or expanding community facilities in Burray

An outline methodology to fund, plan and implement the recommended option over a defined timescale

A presentation to the BCA committee outlining the above findings and recommendation - this will include a question and answer session







- I had attended Pilates classes at the hall, but it became so cold, for example I needed to wear two pairs of socks and three layers of tops due to no heating. it became unsustainable, hence the move to Cromarty hall. Here the room is clean and carpeted providing a better environment with which to practise Pilates and voga. The Burray Hall can fall short with a clean floor. I once had a drawing pin scratch my arm. Thankfully it was under my mat, so no harm done. I'm surprised adult exercise classes (other than 'accessible chair') wasn't on the list of activities that would draw me to using the hall more. I often look at and admire the photographs displayed on the Hall walls. I'm not aware of a photographic club in Burray, but I'm guessing there must be one. Advertising issue? Could the crazy golf be made more of? A regular club of 'crazy golfers'. Competitions? Or perhaps it's too niche? It's great to see there are lots of activities for children. When living on Papa Westray, there were lots of community gatherings during the Winter months, meals and dances, pizza nights with games eg a table tennis, indoor bowls and table top games. It got us out during those dark cold windy evenings. I am relatively new to Burray, so perhaps you do this already, apologies if that's the case. There is also the famous Papay coffee mornings every Wednesday. There are the regular 4 or 5 bakers to provide cake and those attending pay £1.00 for coffee/tea with free fill ups and £1.00 per cake. It helps raise money for charity and a great way for folk to meet for a blether. Have you tried a 'garden club'? I know there is one at the Hope, but a lot of folk seem reluctant to drive there, especially in winter
- Hall heating could be improved!
- It's great to have access to it and really value everything the committee and community association do. I would like to help more but young kids and already coaching sports
- I'm afraid I'm not currently in a position to help due to work commitments but I
 hope to be able to in the future
- Yes, I would rather pay for my child to attend events where adults have been paid to run it than have to attend with my child at free events
